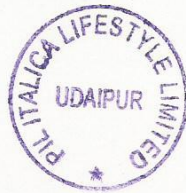

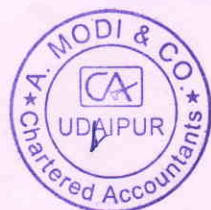
Dear Sir,






