आगजनी की घटनाओं के बाद जागा निगम प्रशासन उदयपुर के अस्पतालों का फायर फाइटर्स ने किया औचक निरीक्षण

लापरवाही पर अस्पताल प्रबंधन को थमाया नोटिस

उदयपुर। देशभर के अस्पतालों में बढ़ती आगजनी की घटनाओं के बाद उदयपुर नगर निगम प्रशासन एक्शन में आ गया है। मंगलवार को नगर निगम की फायर फाइटिंग टीम ने शहर के पांच प्रमुख अस्पतालों का औचक निरीक्षण किया। जहां लापरवाही मिलने पर नगर निगम की टीम ने अस्पताल प्रबंधन को नोटिस जारी किया। साथ ही अगले 24 घंटे में फायर फाइटिंग सिस्टम को दुरुस्त करने के निर्देश भी दिए।

उदयपुर के मुख्य अग्निशमन अधिकारी राकेश व्यास ने बताया कि हाईकोर्ट के आदेश के बाद शहर के अस्पतालों का औचक निरीक्षण किया गया था। जिनमें शहर के 10 अस्पतालों में फायर फाइटिंग सिस्टम में कमी और लापरवाही नजर आई है। जहां फिलहाल कोरोनावायरस मरीज भर्ती है। ऐसे में अस्पताल प्रशासन को नोटिस जारी कर बदहाल सिस्टम को दुरुस्त करने के आदेश दिए गए हैं। जिसे दरुस्त नहीं करने पर किसी भी अनहोनी और हादसे की जिम्मेदारी अस्पताल प्रशासन की होगी।

मुख्य अग्निशमन अधिकारी राकेश व्यास ने बताया कि देश के महाराष्ट्र और गुजरात में अस्पतालों में आगजनी की घटनाओं के बाद हाईकोर्ट के निर्देश पर उदयपुर नगर निगम ने औचक निरीक्षण किया गया है। अब तक उदयपुर के सरकारी और गैर-सरकारी 10 से अधिक अस्पतालों का फायर शाखा ने निरीक्षण किया है। जहां स्मोक डिटेकटर, नोजल और वाल्व खराब मिले। वहीं कछ अस्पतालों में फायर फाइटिंग सिस्टम को ऑटो मोड पर नहीं कर रखा था। जिसकी वजह से बड़ा हादसा हो सकता है। ऐसे में अगले 24 घंटे में इन्हें दुरुस्त करने के आदेश दिए गए हैं। ऐसा नहीं करने पर भवन मालिक के खिलाफ कानुनी कार्रवाई की जाएगी।
