Sub: Scrutinizer's Report on "Voting through Postal Ballot by Electronic Means" from 8th July'2023 to 6th August'2023 pursuant to the Notice of Postal Ballot issued by M/s Sreeleathers Limited, (CIN : L67190WB1991PLC050656) dated 23rd June' 2023.

Dear Sir,
