1. All Invoices are payable 30 days after date of invoice unless otherwise stated on the invoice.
2. A Service Charge will apply on the amount of any overdue account from the date such account becomes overdue. The current rate is 1.5% per month and subject to change on notification by TMP Marine Products.
3. Every transaction indicated or referred to in any notice, statement, confirmation and communication and every statement of account shall be deemed and treated as authorized and correct and as ratified and confirmed by the customer unless TMP Marine Products receives from the customer written notice to the contrary within fifteen days of the date of such

communication.

- 4. No returns shall be accepted unless authorized by TMP Marine Products. All returns are subject to a 15% restocking charge.
- 5. The account must be kept current; failure to do so may result in it being placed on a Payment in Advance basis.
- 6. In the event TMP Marine Products seeks legal counsel to collect amounts or obtain product or goods from the Purchaser, the Purchaser shall be responsible to pay TMP Marine Products attorney fees, whether or not a suit is filed. In the event of any suit action, arbitration, bankruptcy proceeding, or appeal arising out of this Agreement, the non-prevailing party agrees to pay prevailing party's costs and reasonable attorney's fees.
- 7. The Customer hereby authorizes TMP Marine Products to obtain such credit information as may be deemed necessary in connection with the establishment and the maintenance of a credit account, or for any other direct business requirement.
