HyperX France Instagram Giveaway Competition 19/06/2023

These Terms & Conditions govern the HyperX France Twitter Giveaway Competition ("Competition"). This Competition is promoted by HP FRANCE SAS, société par actions simplifiée (simplified joint stock company), with a share capital of EUR 72,010,928 having its registered office at 14, rue de la verrerie, in Meudon (92190), registered at the Trade and Companies Register of Nanterre under number B 448 694 133 ("Promoter", "HP" or "We").

- 0. A Participant is any France resident individual aged 18 or over who enters the Competition, other than those people listed in clause 3 below ("Participant", "you" or "your").
- 1. By submitting a Competition entry, you are agreeing to be bound by these Terms and Conditions. Please retain a copy for your information.
- 2. Employees of HP, and their immediate families, anyone else involved in the operation of the Competition or anyone that appears on a government-restricted persons list are excluded from entering.

COMPETITION PERIOD & ENTRY CRITERIA

- 4. CONTENT
