## Section 4: First-Aid Measures

#### 4.1 Description of first-aid measures:

**Inhalation:** If symptoms develop move victim to fresh air and keep comfortable for breathing. Get medical attention if you feel unwell.

#### 4.2 Most important symptoms and effects, acute and delayed:

Inhalation: Breathing fertilizer spray or mist may cause nose and throat irritation.

**Eye Contact:** Contact with the liquid or spray may cause mild eye irritation. Symptoms of irritation include redness, tears and slight discomfort.

**Skin Contact:** Contact with the liquid may cause mild irritation. Symptoms of irritation may include mild discomfort, redness, dryness or cracking.

Ingestion: Low acute toxicity by the oral route. Swallowing causes nausea, vomiting, chills and diarrhea.

#### 4.3 Indication of any immediate medical attention and special treatment needed: Not available

#### 4.4 Medical Conditions Aggravated by Exposure:

Skin contact may aggravate an existing dermatitis.

## Section 5: Fire-fighting Measures

#### 5.1 Extinguishing media:

## 5.2 Special hazards arising from the product:

#### Not flammable or combustible.

Product may burn if all of the water has evaporated or boiled away. Products of combustion may include toxic and corrosive sulfur dioxide and potassium oxide.

#### 5.3 Special protective equipment and precautions for fire-fighters:

Firefighters should wear full protective gear including self-contained breathing apparatus when fighting chemical fires. Any water runoff should be minimized and contained.

#### 6.1 Personal precautions, protective equipment and emergency procedures:

Stop the spill if safe to do so. Restrict access to the spill area.

### 6.2 Environmental precautions:

Collect the spilled liquid by pumping or using a suitable inert absorbent (e.g. sand, earth or other commercial absorbent product). Collect spilled material and contaminated absorbents and place in an appropriate container for reclamation or disposal. Clean the spill area with water.
