#### ORDER MINIMUMS

Opening order minimum is \$200 or 20 pieces. Reorder minimum is \$100. Orders under \$100 are considered Special Orders and subject to different payment terms. Note: all "pre-assorted sets" are considered 1 piece.

#### **PRICING**

All prices listed are wholesale. MSRP is wholesale x 2.5.

#### **PAYMENT**

Visa, MasterCard, Discover or American Express. A credit card is needed for all orders placed and will be charged upon ordering. Net 30 Terms available upon approval and after fourth order.

#### ORDER FULFILLMENT

As most of our products are one of a kind/small quantity, most orders can be shipped within 1 week of ordering. For pieces that need to be produced, we require 3-4 weeks to produce and ship out. #### SHIPPING

We ship all orders with USPS Priority Mail with insurance from Poughquag, NY. Shipping is added to product invoice. We are not responsible for shipping fees for returned items.

#### INTERNATIONAL SHIPPING

We ship all international orders with FedEx. You are responsible for any import duties and taxes that your country may impose on your order.

#### SPECIAL ORDERS

We accept special orders. Any order under \$100 is considered a special order. Payment for special orders is credit card only, regardless of your usual terms.

#### **CANCELLATION**

There is no grace period for order cancellation since most of our products are instock and readily shippable.

#### **DAMAGES & DEFECTS**
