

# 3 Key Tips for How to Write an Argumentative Essay

Writing a 600 word essay for a professional [essay writer service](#) might be a piece of cake. However, for students and young writers, it can be tedious and worrisome. They will think of dedicating a whole day to it and focus solely on it, which is a waste of a lot of time. To cater to this issue there are many tips and tricks that one can follow. If these tricks are followed stepwise, then one can easily write an essay in no time.

An argumentative essay in the domain of writing is the most common one. The purpose of writing an argumentative essay is to persuade the readers that your stance is right and that is a valid way to think about a certain topic. It states facts and figures from literature to help you stand firm in your stance. While I [write my paper](#) on an argument-based topic, I am not troubled as I know how to do it in less time. I assure you that if you follow these steps, you can do it right in less time as well.

Create an outline of the essay such that it should start with an introduction, then three body paragraphs, and one concluding paragraph. A nice 600 words essay or 2 pager essays can be easily split into 5 content paragraphs to serve the purpose.

Once you are done with the outline, start thinking about your topic. Rack your ideas and see which side you think is the right one. You should assure that you have your own stance, or else you will be puzzled while writing. Choose one side clearly and then start with your research.

Keep a pen or paper by your side to note down the arguments. Start with the research on google scholar. Find solid arguments supporting your stance with evidence. The evidence should be a statistical or theoretical framework that seconds your thoughts. Keep these evidence sources open in your browser and now come to writing.

The first step is to write about your topic. It is better to read some blog or article on the topic to define the theme of your essay. The definition should be short and to the point to serve the purpose of an introductory line and a powerful introduction. The next part of the introduction is to write a brief background of that topic. You can write about how the topic evolved or what are the key elements of the topic. Once you are done with the background only one thing is left that is the thesis statement. You should not get stuck here; instead, move towards the next step and leave three to four lines of space for the thesis statement. Now start with your arguments or claims of the three body paragraphs. The first two body paragraphs should base on your stance on the argument. While the third one should have the counterarguments with evidence that negate, why the other side of the argument that you are not supporting is lagging.

After you are done with topic sentences of body paragraphs start with the basis of each argument. This is called a premise that defines the basis of an argument. After you are done with this, open the sources that you found. Quote the evidence in rephrased form and cite it accordingly. if you cannot write my paper in your own words then [pay someone to write my paper](#).

Make sure that after writing about the scholarly source you give the credit to the information provider. The credit is provided in the form of a citation. You should know what format you are following for the citation. It can be APA, MLA, AMA, Chicago, or Harvard. You should know the format to follow and then cite accordingly using the bibliography tool or Zotero software.

After you have shared evidence in your body paragraphs, move towards the last step of finishing your body paragraph that is summing up the whole paragraph. You must revert to the evidence and your claim to assure that they both link and persuade the reader to believe in it. If you hate it, put an expert writer on it. Say [write my paper for cheap](#).

Now you are done with all the body paragraphs. So, you should make the thesis statement. The thesis statement is a composition of all claims in one sentence. It tells what the writer is going to affirm in the whole essay. It contains the essence of all your arguments and tells the writer whether your claims are worthy to read or not.

After a thesis statement, you are only left with the conclusion. The conclusion starts with the rephrased thesis statement, which is followed by a summary of all the paragraphs. Make sure that you don't miss out on any point stated in the essay. Lastly, there is an ending statement that should be effective enough to create an impact and convince the reader that what you said is completely right.

Thus, following these steps will ensure that you write an argumentative essay in no time.
