“CHAMPION” SALES COMMISSION PROGRAM AGREEMENT

ADMIRAL WORLD GENERAL TRADING LLC offers interested persons the opportunity to refer potential clients in exchange for a referral fee payment. To participate in this program please accept this Referral Program.

THIS AGREEMENT is made by and between **ADMIRAL WORLD GENERAL TRADING LLC**, whose address is **112661 Street 8, Al Quoz 1 Showroom 43, Dubai, UAE**, hereinafter referred to as “Company” and you, hereinafter referred to as “Referral Partner”.

WHEREAS, Company provides retail, rental, and services of Sports and Entertainment equipment, accessories, and other products or services, and: **WHEREAS**, Referral Partner desires to promote the Company’s services and products in accordance with the terms and conditions of this Agreement in exchange for a referral fee payment.

NOW, THEREFORE, it is agreed as follows:

1. The Company hereby appoints the Referral Partner as an authorized non-exclusive independent representative to promote all services and products provided by the Company and to refer interested parties back to the Company.
2. Referral Partner shall devote such time, energy, and skill as desired to promote the sale of the Company’s services and products during the term of this Agreement.
3. Referred Opportunity Eligibility Criteria

A qualifying referral will be determined at the sole discretion of the Company in accordance with the following criteria:

- The referral is submitted in writing to any Company employee.
 - The prospective customer does not already have a business relationship with the Company.
 - An identical or substantially similar referral from an alternate source for the same opportunity has not already been received by the Company.
 - The prospective Client signs or issues a Local Purchase Order or signs the Tax Invoice proposed by the Company for the opportunity described by the Referral Partner.
 - This agreement is valid for submission of the referral of prospective customers from the date of signing and submission of the agreement.
 - No responsibility will be taken by the Company for referrals that are illegible, lost, misdirected, improperly recorded, or not received for any other reason.
 - A referral may be disqualified at the sole discretion of the Company if the Referral Partner breaches any of the terms and conditions of the Referral Program.
4. For each referral made by the Referral Partner that results in the sale of the Company’s services or products, the Referral Partner shall be entitled to a referral fee payment. The referral fee is calculated as follows:
 - **10%** of total Invoice Value less VAT = Net Value.
For Example: Sold item at **AED 10,500 – 5% VAT** = Commission from **AED 9,500**. The referral fees set forth in this paragraph shall begin to accrue as of the date of acceptance of this Agreement by the Referral Partner; provided.

Referral Fees will be paid by cheque, bank transfer, or cash in AED currency to the Referral Partner monthly after the Company receives payment in full from the referred customer and the product or service delivered in accordance with the terms and conditions of Company's contract with them. Company shall not be responsible for any lost, misplaced, or undelivered mail and shall not have any obligation with respect to the updating of the Referral Partner bank account or address information. Referral Partner is solely responsible for all applicable federal, state, and local taxes if applied. The company's obligation to pay referral fees to the Referral Partner shall be considered fulfilled upon payment of the agreed-upon referral fees, as described herein. The company shall then be discharged and released of any further obligation to pay referral fees to the Referral Partner on that particular sale and any future sales to the same customer. Referral Partner may not refer themselves and will not receive a discount equivalent to the referral fee amount on their own projects.

5. During the term of this Agreement, the Referral Partner may request sales literature from the Company. Upon termination of this Agreement, Referral Partner agrees to return all remaining sales literature in its possession.
6. This Agreement shall not create a partnership, joint venture, agency, employer/ employee or similar relationship between the Company and the Referral Partner. The referral Partner shall be an independent contractor. Referral Partner shall not be considered an employee of the Company and shall not be entitled to participate in any plan, arrangement, or distribution by Company pertaining to or in connection with any benefits, stock, bonus, profit sharing or other benefits extended to the Company's employees. Referral Partner shall be free to utilize their time, energy, and skill in such manner as he deems advisable to the extent that he is not otherwise obligated under this Agreement.
7. The rights, duties, and benefits of the Referral Partner under this Agreement are personal and may not be assigned or delegated to anyone and do not inure to the benefit of any other person.
8. Referral Partner is not authorized to extend any warranty or guarantee or to make representations or claims with respect to the Company's services and products without express written authorization from the Company.
9. Referral Partner shall indemnify and hold Company harmless of and from any and all claims or liability arising as a result of negligent, intentional, or other acts of the Referral Partner or their agents or representatives.
10. Referral Partner certifies that there no conflicts of interest, breach of confidentiality, non-solicitation, or noncompete obligations regarding the potential client, the Referral Partner's company, or any other party to this Agreement.
11. This agreement, and all transactions contemplated hereunder, shall be governed by, construed, and enforced in accordance with the laws of the United Arab Emirates.
12. Any notice under this Agreement shall be deemed given on the third business day following the mailing of any such notice, email, to the address set forth above or provided by the Referral Partner during the course of business.
13. Procedures for termination are as follows:
 - (a) Either party may terminate this Agreement for convenience by providing thirty (30) days written notice ("Termination Notice") to the other party.
14. This Agreement contains the entire agreement between the parties and any representation, promise, or condition, expressed verbally or in writing, not incorporated herein shall not be binding upon either part.
