#### Storage

Store flavor in airtight, sealed containers at ambient temperature (20-25°C/68-77°F) and <60% relative humidity. Avoid exposure to light, air, and high heat. Use immediately or maintain minimal headspace and store under refrigeration (0-10°C/32-50°F) to aid in preserving the product's integrity.

#### Shelf Life

Typical shelf life is 1 year from date of manufacture when stored in original container and under recommended storage conditions.

Abstrax labels identify the following ingredients: "Water, Hops Oil, Sunflower Lecithin, Potassium Sorbate, Citric Acid". However, pursuant to 21CFR101.100(a)(3)(i), food and beverage products that use Quantum Brite may only need to label the "Hops Oil" since the other ingredients could be considered incidental additives that are present in the final product at insignificant levels and do not have any technical or functional effect in the food. These other ingredients are present in the food by reason of having been incorporated into the food as an ingredient of Quantum Brite, in which the ingredients did have a functional or technical effect. Hops Oil is a FEMA GRAS flavoring pursuant to the Code of Federal Regulations Title 21 Section 101.22(a)(3).

2. Crustacean, Egg, Fish, Milk, Peanut, Sesame Seed, Shellfish, Soybean, Tree Nut, Wheat are allergens recognized by the USA Food and Drug Administration, Food Allergen Labeling, and Consumer Protection Ace of 2004 (FALCPA). FALCPA does not regulate sulfites as allergens. However, sulfites are considered a sensitizing chemical in the USA and will be identified when present at >10ppm.
