
You Will Need The Following Tools

Soft pencil or felt pen to mark tile Reciprocating saw w/metal cutting blade (Sawzall®)

Allen wrench Channel locks or adjustable wrench

Safety glasses Drill (Preferably cordless)

Phillips screwdriver Plumber's Tape




Parts Legend




Installation Instructions

BEFORE YOU BEGIN


Measure the following to ensure your valve will fit properly.





Confirm the installation position and remove the plaster guard (9).






If no tub, keep the tub spout cap (20). Apply plumbers tape on all joint threads needed.




If welding, plumbers tape is not necessary.





If there is a bath tub, remove the tub spout cap (20). Apply plumbers tape on all joint threads needed.






Drill screws to stud to fix main valve body.


Installation Instructions






Connect the water and confirm there is no water leakage.






Install trim plate (7).





Install diverter trim sleeve (14) and valve trim sleeve (16). Screw in trim nut (11).





[Step 1] Insert allen wrench into diverter threaded pin and thread to diverter body (4). Place on top of diverter cartridge, and thread with allen wrench until secure.


[Step 2] Thread diverter handle (6) onto diverter threaded pin (5).

[Step 3] Install valve handle and secure with set screw (2) using allen wrench. Place cover (3) over set screw (2).

OPERATION:

VALVE FUNCTIONS:




Turning valve ON, lift valve handle up.


Hot Cold

While ON, turn valve handle to the left for HOT and right for COLD.

DIVERTER FUNCTIONS:



Diverter handle facing up for showerhead.



Diverter handle facing to the right for hand shower.

Usage

Diverter valve controls the showerhead and handshower. Refer to drawings on "OPERATION" step.

Always turn cold water on first to help prevent any accidental burning or scalding; especially for children and elderly.

DO NOT use any part of the valve as a support device.

Care and Maintenance

To keep your valve looking new, wipe down after each use with a soft cotton cloth.

Protect your valve from hard water stains and mineral deposits by periodically using an auto spray wax.

Clean using mild liquid soap and a non-abrasive sponge or cloth. Rinse with clean water.

Do Not Use Any Kind Of Chemicals Or Abrasives!

MANUFACTURER'S LIFETIME LIMITED WARRANTY

- 1. Defects Covered; Warranty Period: Pulse Shower Spas, Inc. ("Pulse") warrants to the original consumer purchaser who purchases this shower spa (the "Product") for use in his or her own home, that the Product will be free from defects in material and manufacturing workmanship for as long as the original consumer purchaser owns that same home. For all other purchasers (including, but not limited to purchasers for industrial, commercial and business use), the above warranty will apply for a period of 5 years from the original date of purchase.
- 2. Remedy: If the Product does not conform to the above warranty, Pulse, at its option, will repair or replace the Product, free of charge, or refund your purchase price. For warranty claims, please visit www.pulseshowerspas.com/index.php/warranty. Pulse may require that you return the Product to Pulse, shipping prepaid, in which case Pulse will provide you with a return materials authorization number (RMA). Pulse may also require that you provide evidence of the date you purchased the Product. Pulse will ship a new or repaired Product to you, at the expense of Pulse, or refund your purchase price. Service labor performed by you or others in connection with the removal or replacement of the Product will not be reimbursed by Pulse.
- 3. Exclusions: Pulse shall not be responsible for failure of the Product, and the above warranties will not apply, if the Product fails as a result of improper installation, improper use, modifications or repairs by anyone other than Pulse, or accident or abuse (including damage during shipment).
- 4. Warranty on Repairs and Replacements: For consumer purchasers who purchased the Product for home use, repaired or replacement Products will continue to be covered under this warranty for as long as he or she owns that same home. For other purchasers, repaired or replacement Products will be covered for the balance of the original warranty period.
