### Terms

All invoices must be paid in U.S. Funds. Critter Love® accepts PayPal and Square payments. Orders can be prepaid with personal checks, bank checks, or money orders.

No C.O.D.s. There is a \$35 NSF fee for returned checks. Orders will not be processed until payment clears when paid by check.

Critter Love® has a minimum order policy of \$150.00 in state and \$250.00 minimum order for all international orders. A 3% surcharge to cover PayPal fees will now be included in your billing. Prices are subject to change.

### Pricing

Critter Love® wholesale price list includes a suggested retail price. Critter Love® customers which have qualified for this discounted price must use this retail price as a guide. With the exception of an occasional sale or special, the suggested retail price should be used as the **minimum** retail price. Critter Love® reserves the right to make price changes at any time without notice. Wholesale customers agree to make every effort to maintain suggested retail pricing as provided by Critter Love®.

### Dealers

### Shipping
