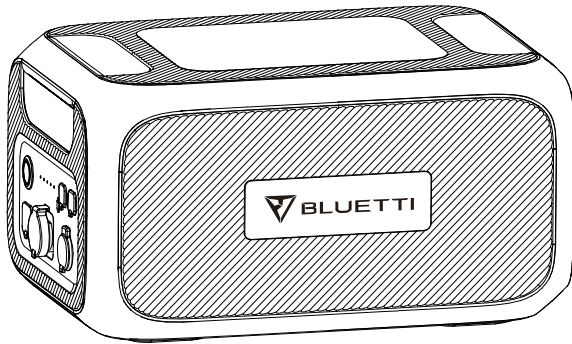

B230, expansion battery module owns 2048Wh capacity to support BLUETTI AC200MAX series. AC200MAX + B230 setup can be an emergency power center to run your home or travel essential appliances , or with enough solar panels, you can even live off-grid life on the way.

# 3.SAFETY INSTRUCTION

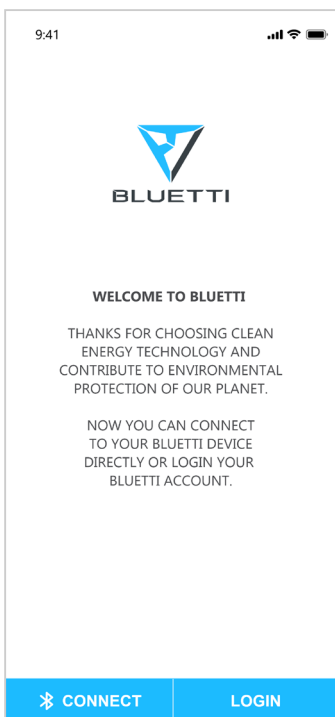

- DO NOT operate in wet conditions. If the equipment becomes wet, please let the unit dry completely before using.
- Please ensure proper ventilation while in use and do not obstruct fan openings. Inadequate ventilation may cause permanent damage to equipment.
- DO NOT move the unit while operating as vibrations and sudden impacts may lead to poor connections to the hardware inside.
- Warning: DO NOT insert foreign objects into any ports of the B230. Please operate it carefully and keep children away from it.
- In case of fire, only a dry powder fire extinguisher is suitable for the product.




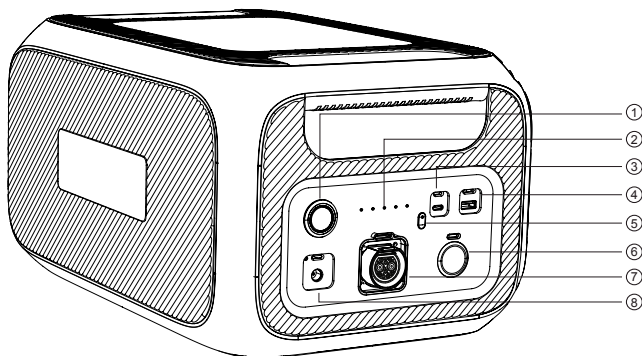

## 6.LET`S GET STARTED

- Power On: Long press on the power button. The power button indicator will illuminate.
- Power Off: Long press of the power button for 2 seconds. The power button LED indicator will turn off.

## 7.FEATURES



### 01 Power Button

Press to turn ON/OFF the unit.

### 02 LED Capacity Indicator

Show the remaining capacity of the unit(0-20-40-60-80-100%)

### 03 USB-C

Can be used via USB-C to USB-C cable to charge most devices in the market such as Pixel Phone, Macbook Pro at 100W Max.

### 04 USB-A Output Port

Supports QC3.0 protocol.

### 05 DC Button

Press to turn ON/OFF DC output.

### 06 Cigarette Lighter Port

Output port for devices with corresponding plug such as vehicle-use vacuum, mini fridge.

### 07 Battery Expansion Port

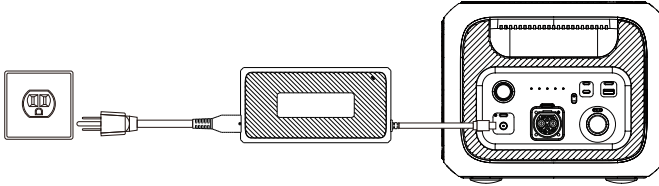
To connecting B230 with AC200MAX.

### 08 Input Port

To charge B230 via T500 adapter. For vehicle, extra solar power via D050S.

## 8.RECHARGE

### AC Charging (Default)



(Charge B230 through T500 adapter)

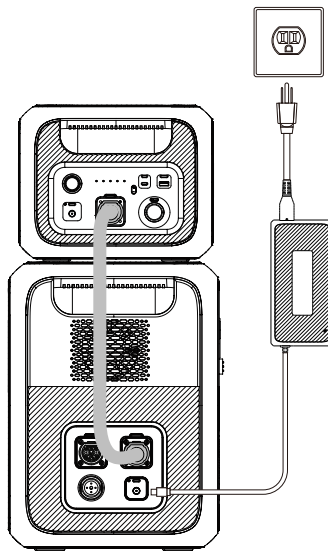
Estimation of Charging Time:  $2048\text{Wh} / 500\text{W(T500 adapter)} + (0.5 - 1 \text{ Hrs Trickle Charging}) = 4.6\text{-}5.1\text{Hrs}$  for AC200MAX fully charged via T500 adapter only.

Estimation of Running Time:  $2048\text{Wh} / 96\text{W(MacBookPro)} * 0.9(\text{DoD}) * 0.9(\eta) = 17 \text{ Times}$ .

DoD indicates Depth of Discharge.

$\eta$  indicates efficiency.

### Expansion **Charging 01**



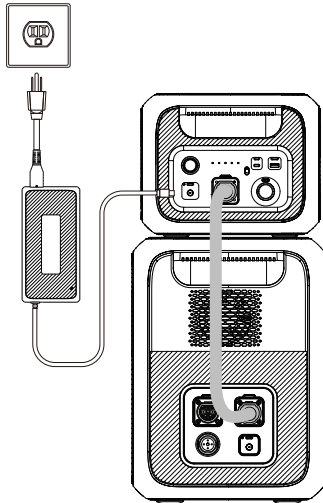
(Recharge AC200MAX by T500 adapter)

**SOC-A: the remaining capacity of AC200MAX**

**SOC-B: the remaining capacity of B230 battery pack**

When SOC-A = SOC-B, both of the two units will be charged simultaneously.  
When SOC-A < SOC-B, AC200MAX will be charged first by all power sources in the Capacity Fusion System until SOC-A = SOC-B, then both of the two units will be charged simultaneously.  
When SOC-A > SOC-B, only AC200MAX will be recharged.

(T500 adapter on B230)

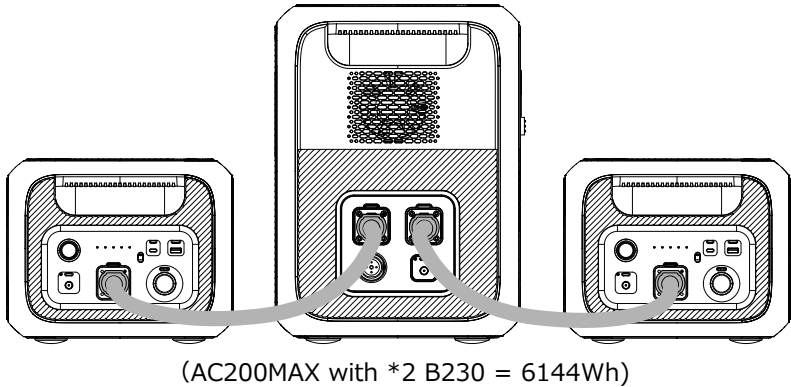
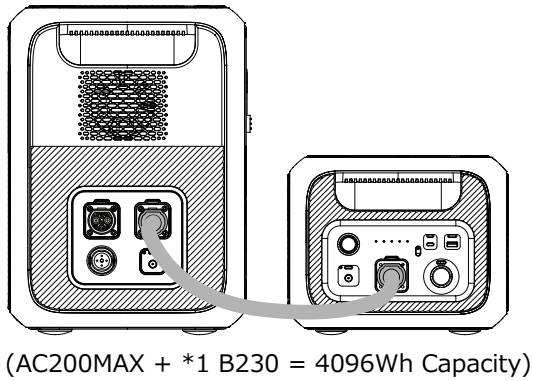
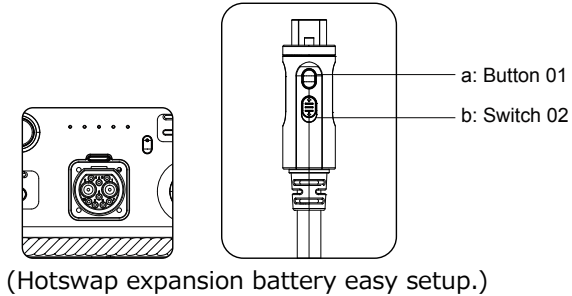
When SOC-A = SOC-B, both of the two units will be charged simultaneously.  
When SOC-A < SOC-B, B230 will be charged by exterior power source(eg.T500 Adapter), AC200Max will be charged by B230.  
When SOC-A > SOC-B, B230 will be charged first by all power sources in the Capacity Fusion System until SOC-B = SOC-A, then both of the two units will be charged simultaneously.

# 9.AC200MAX + B230 EXTRA BATTERYYS

Step 1: Turn ON/OFF B230.

Step 2: Press the button(a) and fully plug Battery Expansion Cable into the battery port of AC200Max.

Step 3: Push forward the switch(b) to lock the connection.

- How to claim the warranty?

Please refer to the warranty card you received from where you have ordered the product from.

- Can the unit be upgraded?

When B230 has been connected to AC200MAX, the firmware including ARM, DSP, IoT and BMS can be upgraded online through OTA via BLUETTI APP.

- Can it be charged and discharged at the same time?

Yes B230 supports simultaneous recharge&discharge.

- How to store B230?

We recommend a 3-6 months charging to 80% capacity to extended the battery life, over-discharge will damage the battery cell.
