5.3. Advice for firefighters

Protection during firefighting: Keep upwind of fire. Wear full firefighting turn-out gear (full Bunker gear) and

respiratory protection (SCBA). Avoid generating dust. Cool closed containers

exposed to fire with water. Dust may form flammable mixture with air.

6. ACCIDENTAL RELEASE MEASURES

6.1. Personal precautions, protective equipment and emergency procedures
