

PATIENT INFORMATION LEAFLET: POXCLIN COOLMOUSSE

PROPRIETARY NAME, STRENGTH AND PHARMACEUTICAL FORM:

PoxClin CoolMousse 100 ml (Mousse)

Complementary Medicine: D33.6 Western Herbal Medicine.

Read all of this leaflet carefully because it contains important information for you.

PoxClin CoolMousse is available without a doctor's prescription to provide relief from skin irritation, itching, burning and sensitivity associated with chickenpox. Nevertheless you still need to use **PoxClin CoolMousse** carefully to get the best results from it.

- Keep this leaflet. You may need to read it again.
- Do not share **PoxClin CoolMousse** with any other person.
- Ask your pharmacist if you need more information or advice.
- Your child must see a doctor if his/her symptoms worsen or do not improve.

WHAT POXCLIN COOLMOUSSE CONTAINS:

Each 100 ml of solution contains:

Aloe barbadensis extract (contains galactoarabinan polyglucuronic acid crosspolymer*)....
6,0 g (max)

*2QR, patented bio-active polysaccharide derived from the Aloe barbadensis inner leaf gel by molecular filtration process.

The other ingredients are: Allantoin, aqua, betaine, Chamomilla recutita flower extract, ethylhexylglycerin, glycerine, laureth-9, Lavandula angustifolia flower/leaf stem extract, PEG-40 hydrogenated castor oil, panthenol, polyglyceryl-10 laurate + aqua, sodium cocopolyglucose tartrate.

Preservatives: Ethylhexylglycerin 0,10 % m/v, phenoxyethanol 0,90 % m/v

WHAT POXCLIN COOLMOUSSE IS USED FOR:

PoxClin CoolMousse helps to provide relief from skin irritation, itching, burning and sensitivity associated with chickenpox. It has a cooling and soothing effect and conditions the skin whilst providing relief.

PoxClin CoolMousse contains the 2QR-complex, a patented bio-active bacterial blocker derived from the Aloe barbadensis plant. The 2QR-complex binds itself to harmful bacteria and blocks it from attacking the skin, thus lowering the risk of infection and supporting

the skin's natural healing process. The 2QR-complex helps to protect and soothe irritated skin, reduces skin itchiness and improves the condition and texture of the skin. Other ingredients in **PoxClin CoolMousse** help to cool, soothe and condition the skin.

BEFORE YOU USE POXCLIN COOLMOUSSE:

Do not use PoxClin CoolMousse:

- If your child is hypersensitive (allergic) to any of the ingredients of **PoxClin CoolMousse**.

Special care should be taken with PoxClin CoolMousse:

- **PoxClin CoolMousse** is intended for use in children.
- Avoid contact with the eyes. Should **PoxClin CoolMousse** enter the eyes, wash with plenty of clean water. Should an irritation persist, seek advice from your doctor, pharmacist or healthcare professional.
- **PoxClin CoolMousse** should not be used continuously for more than 30 days.
- Chickenpox can pose a high risk to adults, pregnant women and infants below the age of 6 months. In these cases, a doctor should be consulted before using **PoxClin CoolMousse**.
- Should your child seem more unwell than would be expected, or if he/she develops a fever, or if the rash spreads to the eyes, or if the skin around the spots becomes swollen, painful or very red, please seek the advice of your doctor.
- Consult your doctor if you are unsure that the condition is actually chickenpox.
- Always speak to your doctor, pharmacist or healthcare professional if you have any queries.

Pregnancy and Breastfeeding:

Chickenpox can pose a high risk to pregnant women. If you are pregnant or breastfeeding your baby, please consult your doctor, pharmacist or other healthcare professional for advice before using PoxClin CoolMousse.

Using other medicines with PoxClin CoolMousse:

There are no known interactions with other medicines.

Always tell your healthcare professional if your child is taking any other medicine. This includes complementary or traditional medicines.

HOW TO USE POXCLIN COOLMOUSSE:

Keep to the instructions stated in this patient information leaflet or as your doctor or pharmacist has instructed you. You should always check with your doctor or pharmacist if you are unsure.

PoxClin CoolMousse is for external use only.

Shake the bottle before use. When first using **PoxClin CoolMousse**, two to three pumps of the foam dispenser may be needed for the foam to emerge. Apply at least three times a day or whenever relief is required. Apply a generous amount and gently dab it into the skin.

PoxClin CoolMousse is a light, smooth mousse and is quickly and easily absorbed by the skin.

For an added cooling effect, store **PoxClin CoolMousse** in the fridge.

PoxClin CoolMousse provides relief from itchiness and protects the skin, resulting in less scratching and fewer infections.

Frequent application of the mousse may enhance its effect.

It is recommended to apply the **PoxClin CoolMousse** prior to change of clothing or whenever relief is required.

You should consult a doctor if your child's condition worsens or does not improve.

If PoxClin CoolMousse is accidentally swallowed:

If **PoxClin CoolMousse** is accidentally swallowed, please contact your doctor or healthcare professional immediately.

POSSIBLE SIDE EFFECTS:

There are no known side effects.

Should your child's general health worsen or if your child experiences any untoward effects while using **PoxClin CoolMousse**, please consult your doctor, pharmacist or other healthcare professional for advice.

STORING AND DISPOSING OF POXCLIN COOLMOUSSE:

Store in a cool, dry place.

Once opened use within 30 days.

Do not use **PoxClin CoolMousse** after the expiry date stated on the foam dispenser or packaging.

Do not use **PoxClin CoolMousse** if you notice visible signs of deterioration.

STORE OUT OF REACH OF CHILDREN.

PRESENTATION OF POXCLIN COOLMOUSSE:

Foam dispenser containing 100 ml **PoxClin CoolMousse**. Each 100 ml foam dispenser is supplied in a cardboard carton, together with a patient information leaflet.

IDENTIFICATION OF POXCLIN COOLMOUSSE:

A light, smooth white mousse with a light and pleasant fragrance as a result of lavender and chamomile extract.
