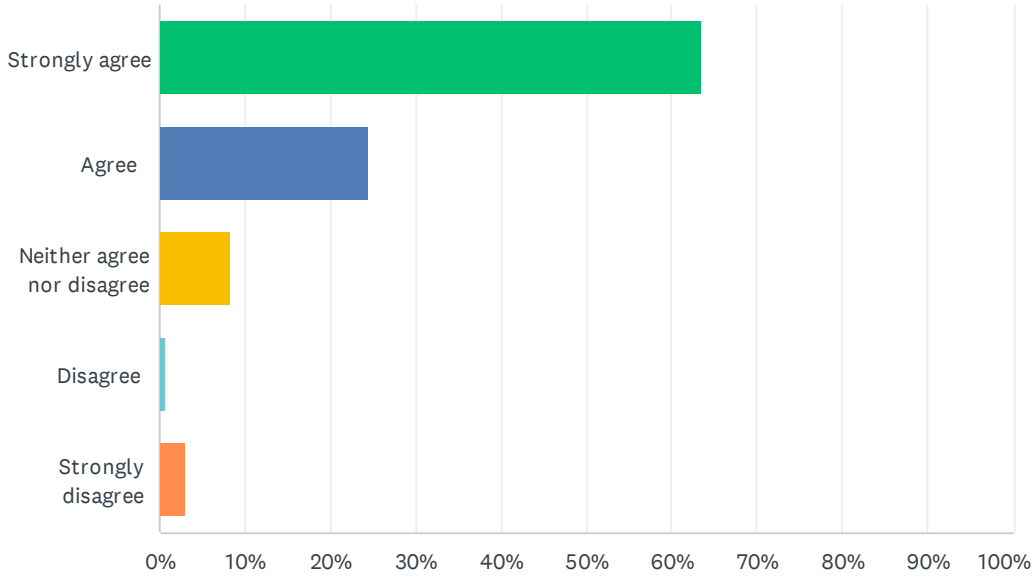


Q1 Zincton is committed to active discussions with First Nations and have invited interested First Nations to participate in our open-sourced Master Planning process. Do you agree with this approach?

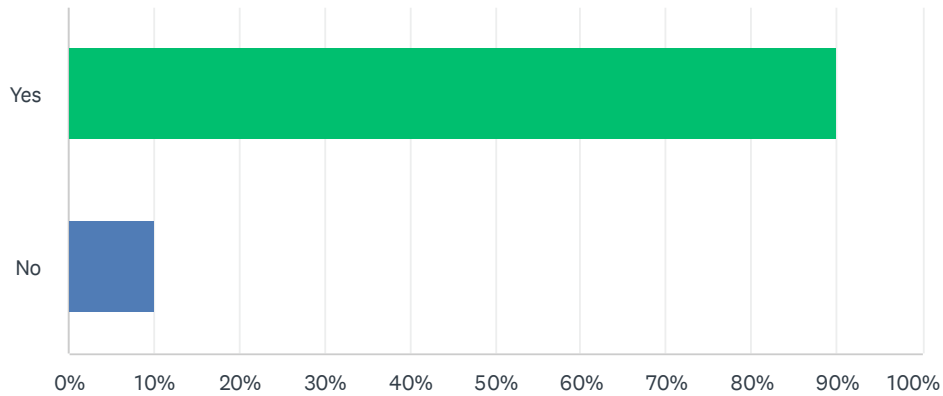

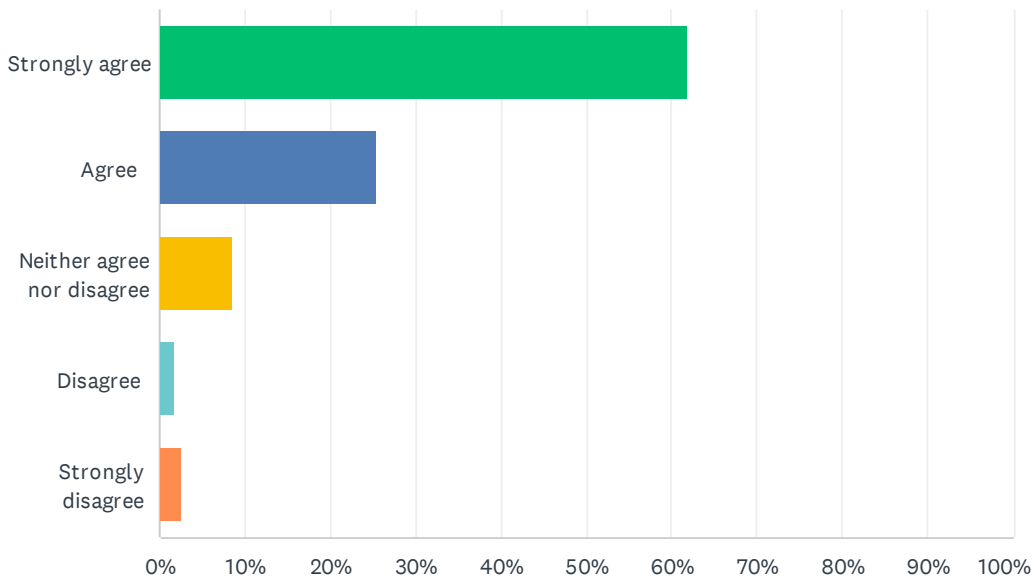

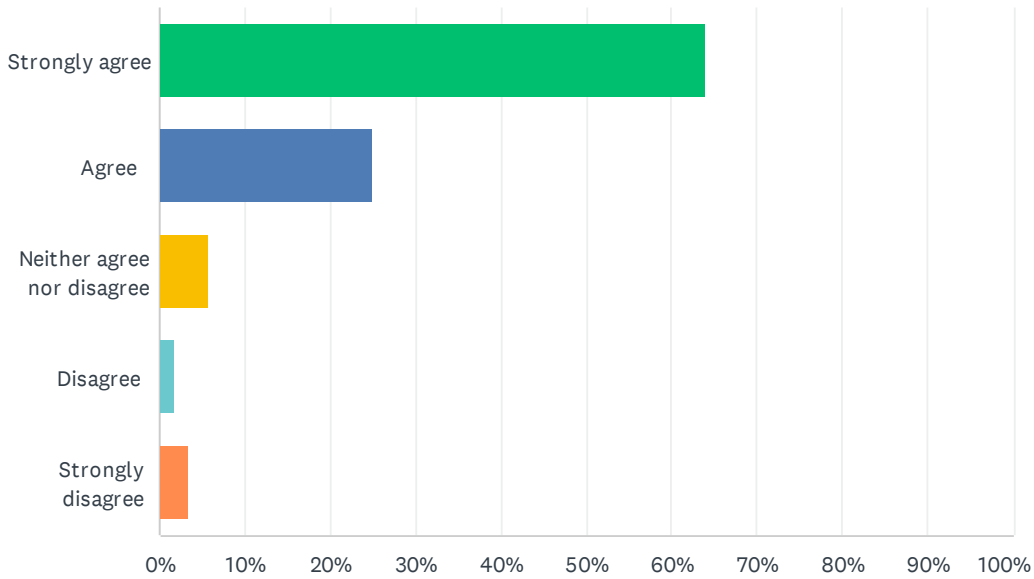

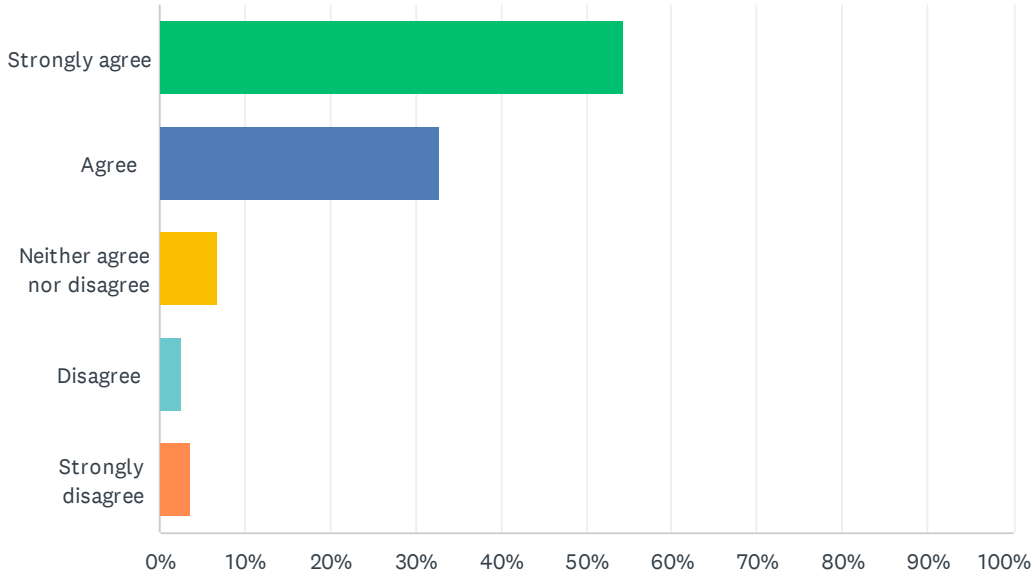

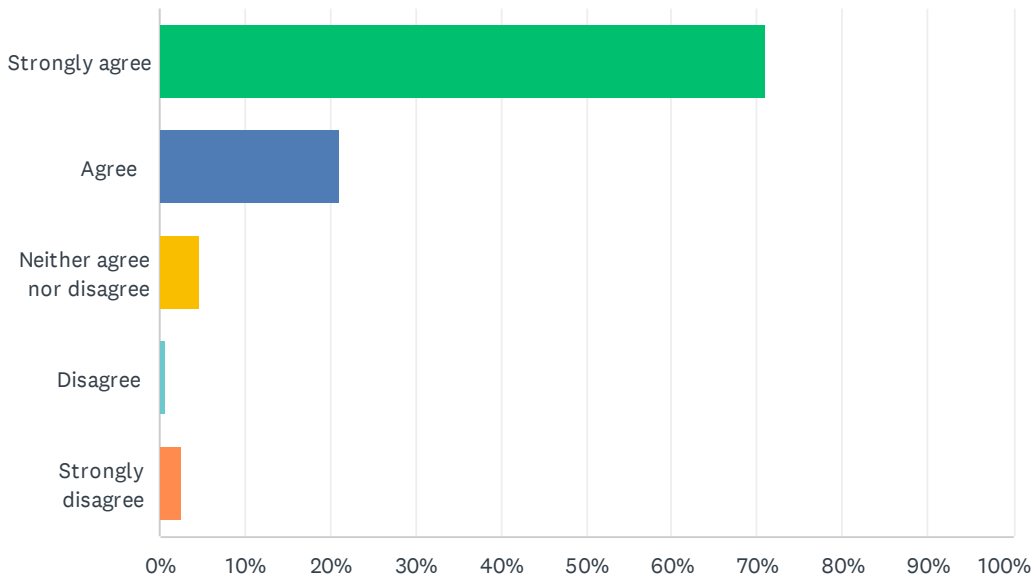

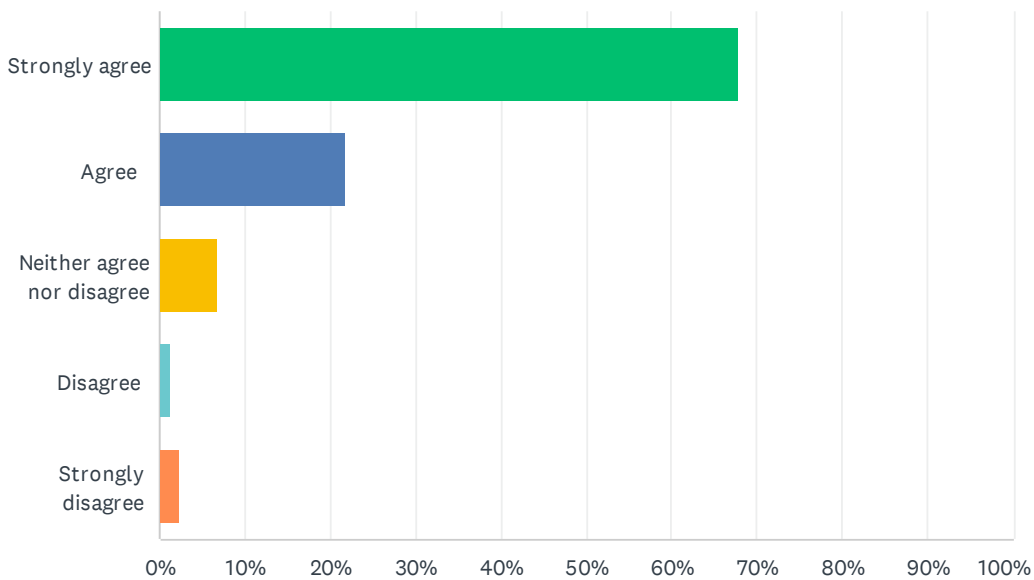

Q7 This region produced more ore than the California, Klondike and Caribou gold rushes combined. The Retallack Mining District is riddled with old mines and tailings. The Whitewater Deep Mine alone has over 20 miles of underground tunnels. To date, there has been no remediation of the toxic waste left behind. The Kaslo River carries this into the Kootenay Lake damaging the fishery. Zincton joined 1% for the Planet and will divert 1% of ski revenue (\$13.4 million over the next 60 years) to study, plan, and assist the remediation of these lands. 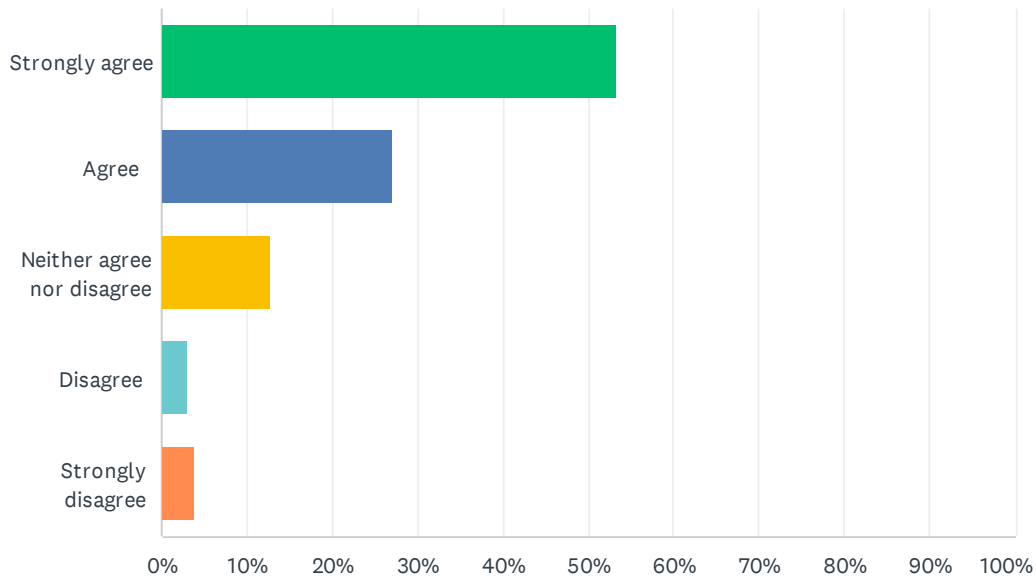

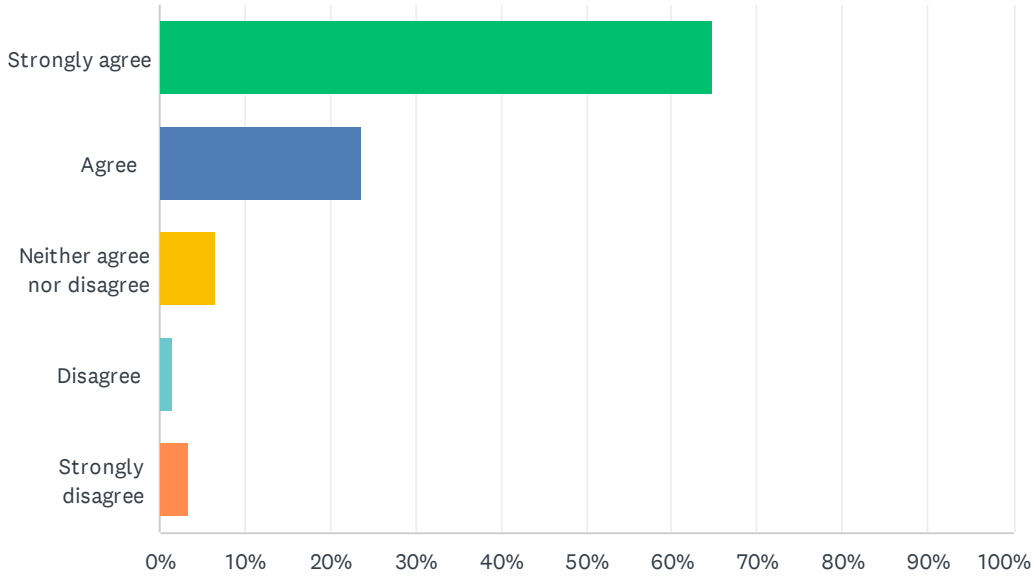

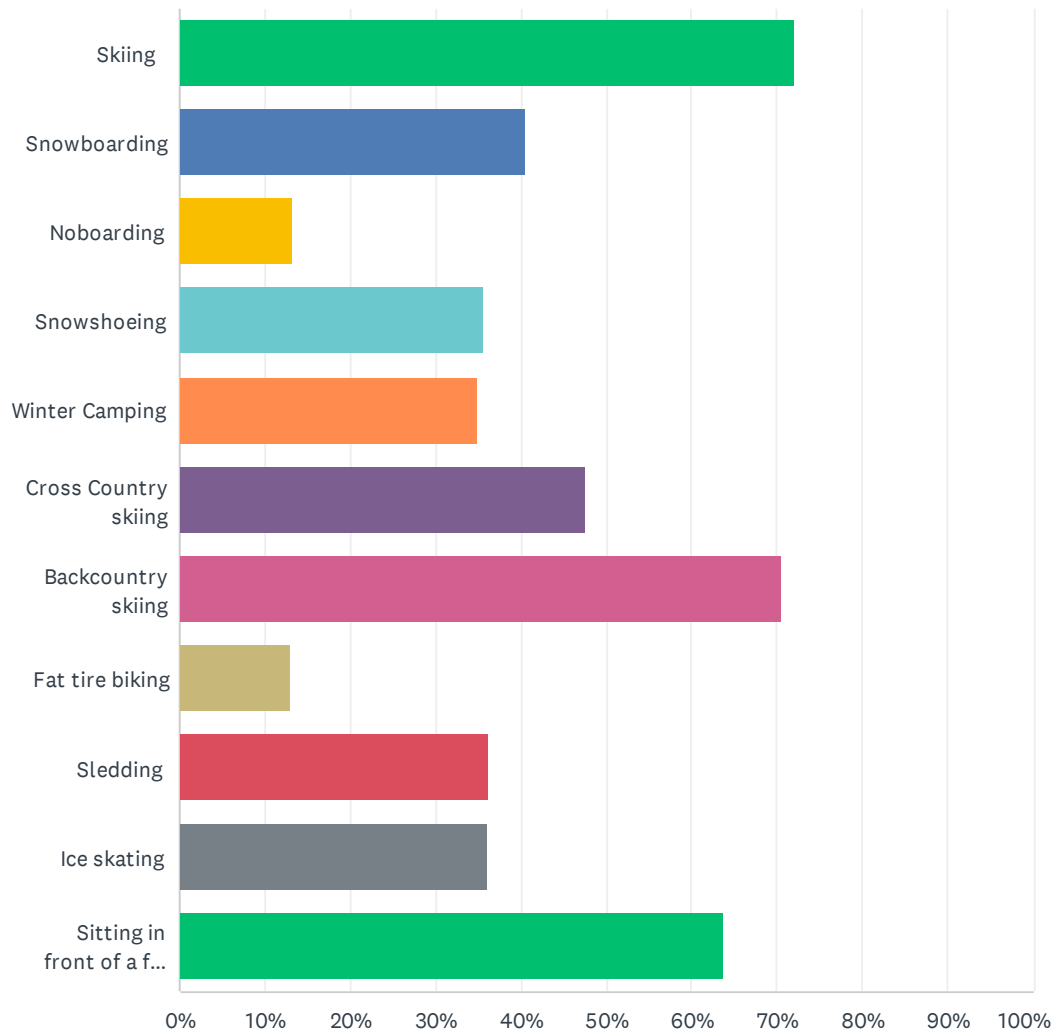

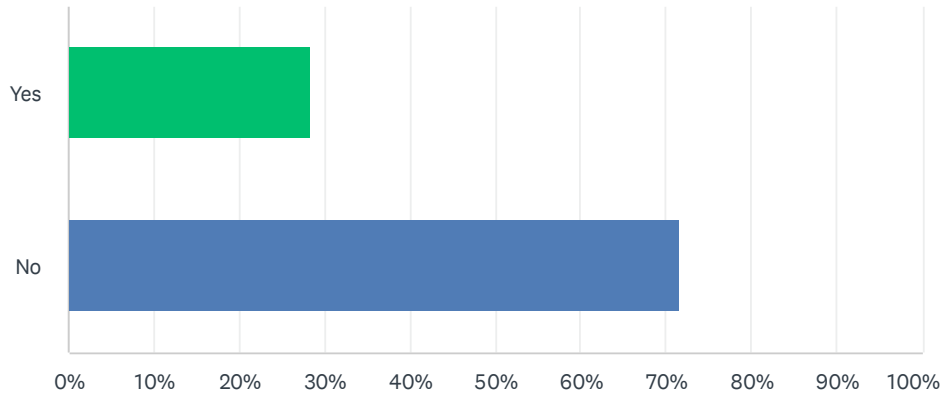

Q12 Have you ever backcountry skied/snowshoed in the proposed Zincton tenure?

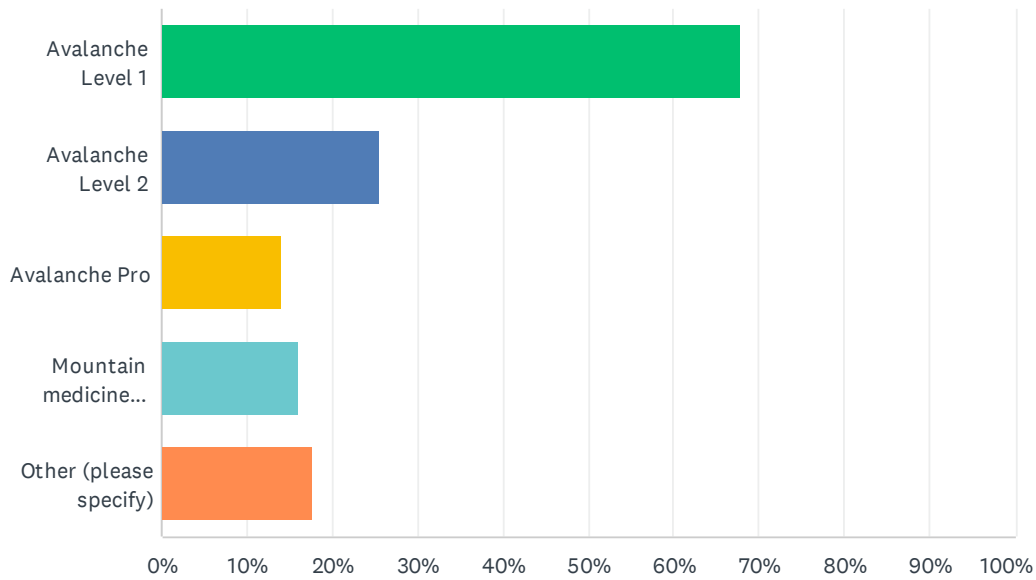

Q13 Do you have any winter backcountry training? Check all that apply.

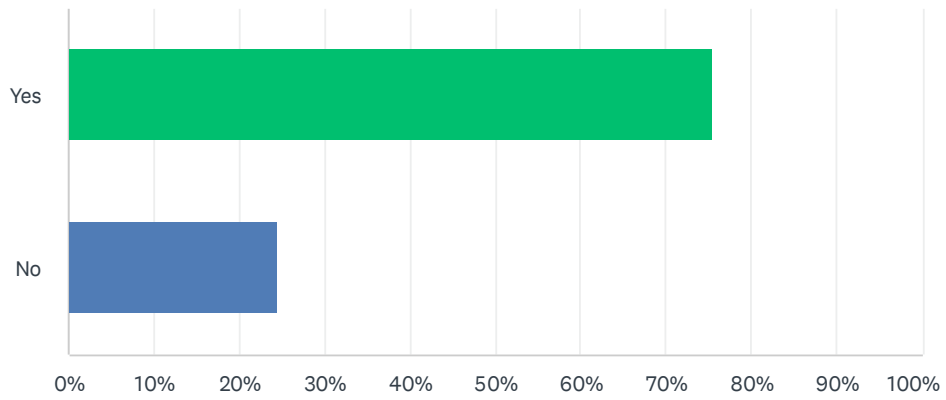

Q14 Would you be interested in winter backcountry safety training?

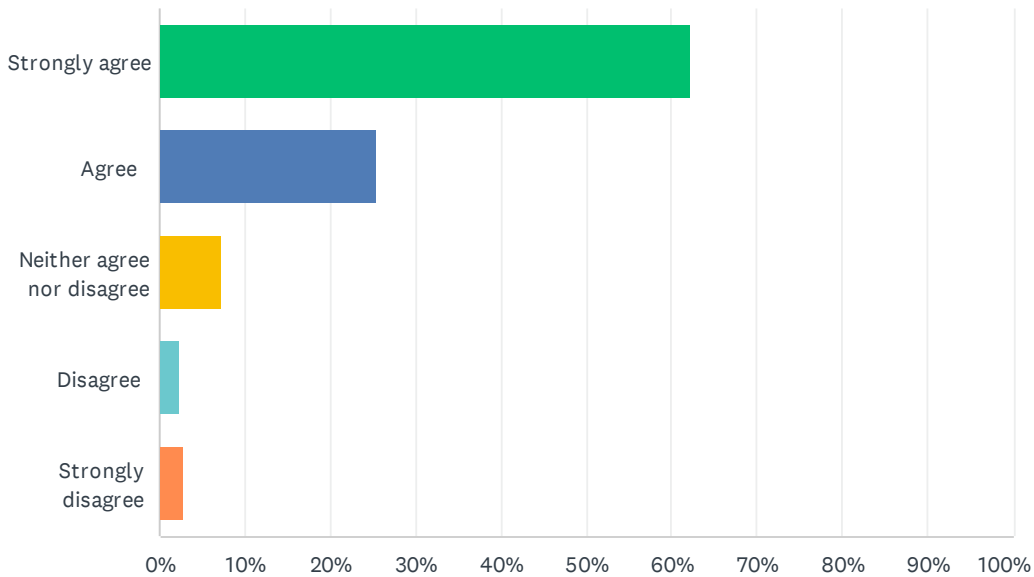

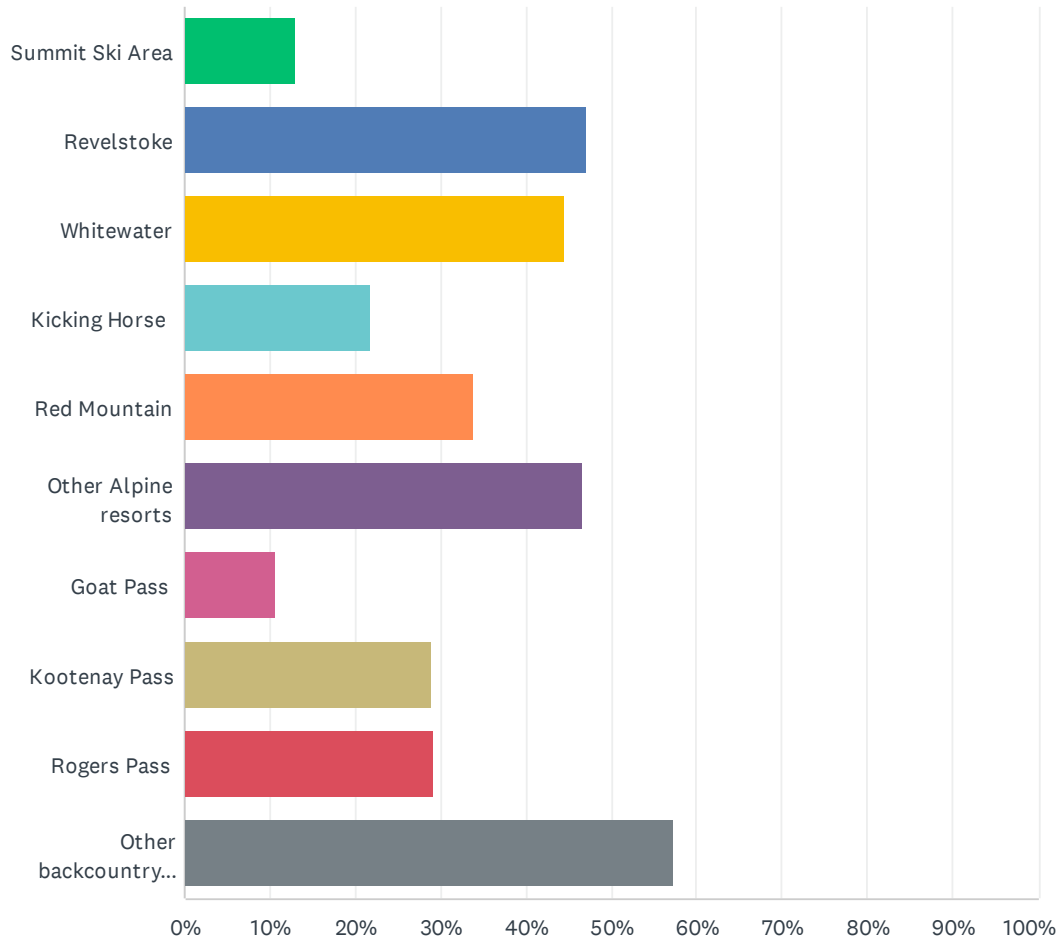

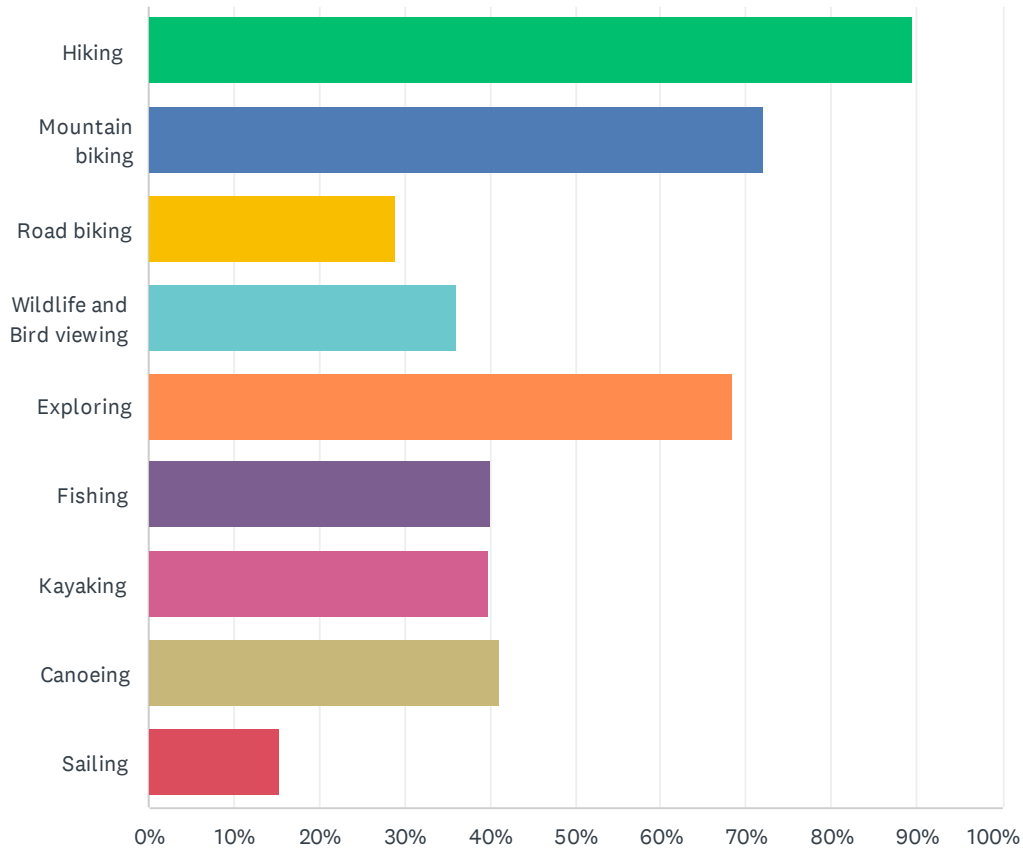

Q17 Which of the following summer activities do you enjoy? Check all that apply.

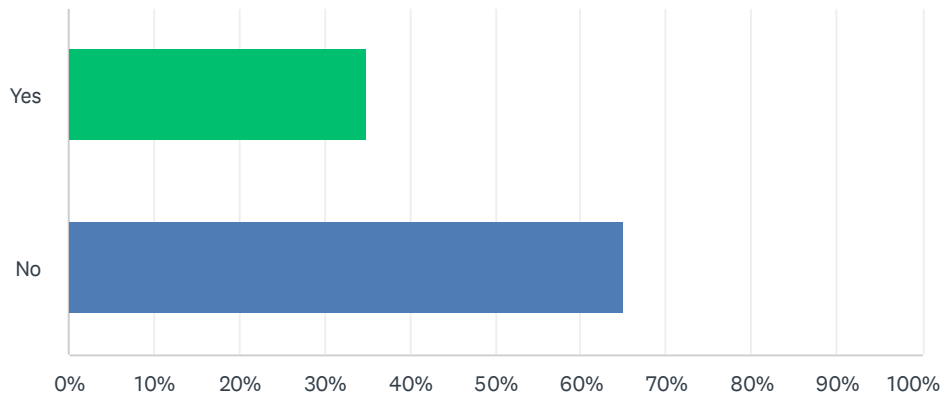

Q18 Have you ever hiked or biked in the proposed Zincton tenure?

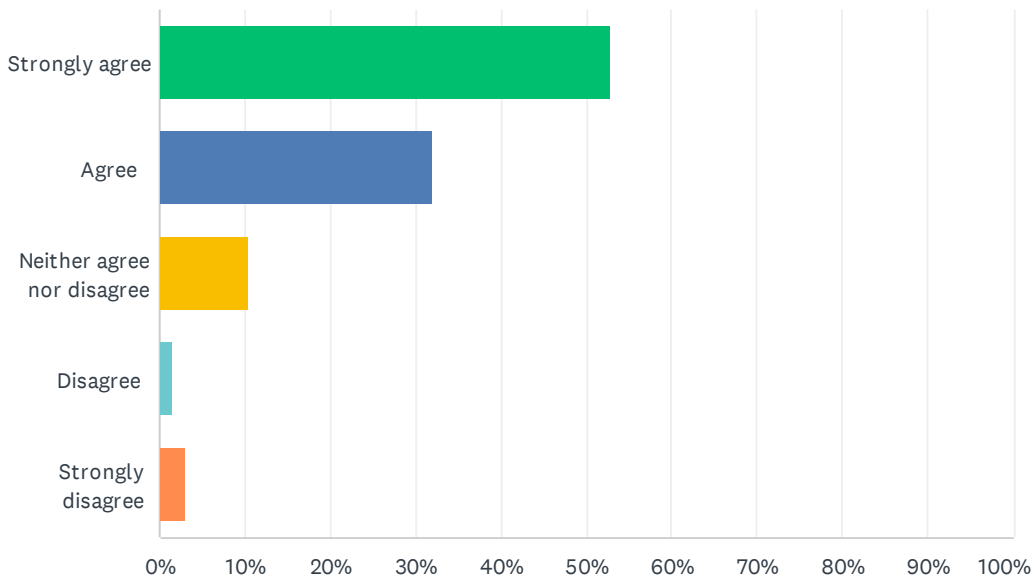

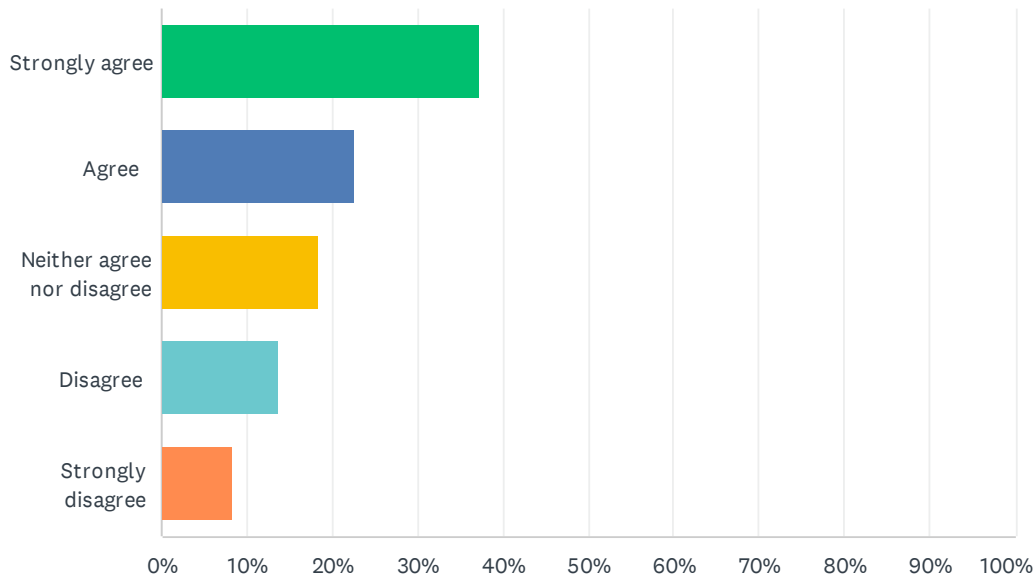

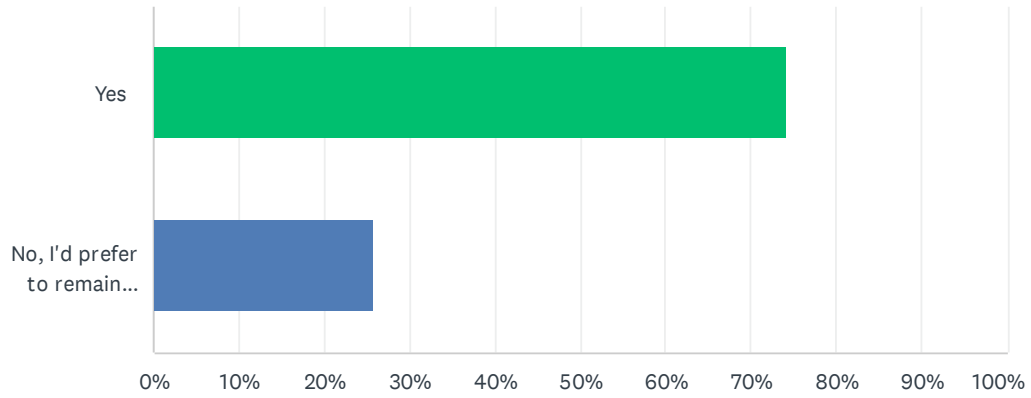
