FIRST AID

If in eyes:	<ul style="list-style-type: none">• Hold eye open and rinse slowly and gently with water for 15-20 minutes.• Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.• Call a poison control center or doctor for treatment advice.
If swallowed:	<ul style="list-style-type: none">• Call a poison control center or doctor immediately for treatment advice.• Have person sip a glass of water if able to swallow.• Do not induce vomiting unless told to do so by a poison control center or doctor.• Do not give anything to an unconscious person.
If on skin:	<ul style="list-style-type: none">• Remove contaminated clothing.• Rinse skin with plenty of water for 15-20 minutes.• Call a poison control center or doctor for treatment advice.
If inhaled:	<ul style="list-style-type: none">• Move person to fresh air.• If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible.• Call a poison control center or doctor for further treatment advice.

PERSONAL PROTECTIVE EQUIPMENT (PPE)

Wear protective eyewear (goggles or face shield), long-sleeved shirt and long pants, and shoes plus socks when mixing or applying Buffer Protect NT™.

ENVIRONMENTAL HAZARDS

Do not contaminate water when cleaning equipment or disposing of equipment washwater.

DIRECTIONS FOR USE

Buffer Protect NT™ functions as a buffering agent and is intended for use with Blossom Protect™ when applied to pome fruits (such as apple, crabapple, loquat, mayhaw, pear, Oriental pear, and quince) and walnuts. Do not apply Buffer Protect NT™ when pome fruit is present. Do not tank mix with copper-based products. Not for aquatic use.

RECOMMENDED USE RATE

Apply with Blossom Protect™ at a 1:4 ratio: one part Blossom Protect™ to four parts Buffer Protect NT™.

1.25 lbs Blossom Protect™ + 5.00 lbs Buffer Protect NT™ in 50-200 gallons of water per acre OR
1.4 kg Blossom Protect™ + 5.6 kg Buffer Protect NT™ in 467-1868 L water per hectare OR
¾ teaspoon Blossom Protect™ + 3 teaspoons Buffer Protect NT™ in 64 fl oz of water per tree.

The pH of a suspension containing 1.25 lbs Blossom Protect™ + 5 lbs Buffer Protect NT™ in 50 gallons of water is 3-4. One Buffer Protect NT™ bag will treat two acres.

STORAGE AND DISPOSAL

Store in original container only. Do not contaminate water, food, or feed by storage or disposal. Do not reuse empty container. Completely empty container by shaking and tapping sides and bottom to loosen clinging particles. Empty residue from container. Then offer for recycling, if available, or dispose of in a sanitary landfill or by incineration or, if allowed by state and local authorities, by burning. If burned, stay out of smoke. Recycling decontaminated containers is the best option of container disposal. The Agricultural Container Recycling Council (ACRC) operates the national recycling program.
