Apply LALSTOP[®] G46 WG by spraying or drenching the growth substrate, by incorporation into the growth substrate, as a foliar spray, by fogging, or by hydroponic or chemigation application in the field as an aqueous suspension.

LALSTOP[®] G46 WG has been evaluated for phytotoxicity on a variety of crops under various normal growing conditions. However, testing all crop varieties, in all mixtures and combinations, is not feasible. Prior to treating entire crop, test a small portion of the crop for sensitivity.

Tank Mixes: Do not combine LALSTOP[®] G46 WG in the spray tank with other pesticides, surfactants, adjuvants, or fertilizers if there has been no previous experience or use of the combination to show it is physically compatible, effective, and non-injurious under your use conditions. Observe the most restrictive of the labeling limitations and precautions of all products used in mixtures.

To ensure compatibility of tank-mix combinations, they must be evaluated prior to use. To determine the physical compatibility of this product with other products, use a jar test. Using a quart jar, add the proportionate amounts of the products to one quart of water with agitation. Add dry formulations first, then flowables, and then emulsifiable concentrates last. CHEMIGATION USE DIRECTIONS GENERAL REQUIREMENTS

- 1. Apply this product only through sprinkler, including center pivot, lateral move, end tow, side (wheel) roll, traveler, big gun, solid set, or hand move, or drip (trickle) irrigation systems. Do not apply this product through any other type of irrigation system.

- 7. Do not apply when wind speed favors drift beyond the area intended for treatment.



SPECIFIC REQUIREMENTS FOR SPRINKLER AND DRIP (TRICKLE) CHEMIGATION

- 1. The system must contain a functional check valve, vacuum relief valve and low pressure drain appropriately located on the irrigation pipeline to prevent water source contamination from back flow.
