\*\*) ND = not detectable. The measured value was below the limit of detection of 0.01% or 100 mg/kg. The expected measurement uncertainty varies with substance and concentration and can be assumed to be a maximum of 5%. For the calculations of the equivalent sums, the respective acid forms were multiplied by the factor 0.877 or 0.878 to conclude the equivalent amount of the

neutral form.
