## TWO-YEAR COMMERCIAL LIMITED PRODUCT WARRANTY

**Warranty Period**  
Breville® warrants to the first-end-user or original purchaser (the "User") that the Breville brand commercial product sold hereunder (the "Product") will be free from defects in material and workmanship under normal conditions of use and maintenance (the "Warranty") for a period of (2) two years from the date of purchase, provided such alleged defect is submitted by User to Breville within thirty (30) days of discovery (the "Warranty Period"). Breville will have no responsibility to honor claims received after the Warranty Period.

**Warranty Coverage**  
If there is a defect in material or workmanship covered by this Warranty and such defect is reported to Breville during the Warranty Period, Breville will repair, replace or refund, at Breville's sole and absolute discretion, that part of the Product that has become defective.  
In connection with all claims under this Warranty, the User will be required to furnish a sales receipt or proof of purchase indicating date of purchase and amount paid. Breville will have the right to inspect the Product at the User's premises, or request the unit be returned to Breville for inspection, and to request all of User's records pertaining to the Product.

**Exclusions from and Conditions to Warranty Coverage**  
This Warranty does not cover the following:

- Product transferred from original owner to another party or moved outside the USA.
- Installation not in accordance with Breville's installation procedures and any applicable standards, regulations, codes and ordinances.

- Damage during Product shipment, freight, movement, assembly, or installation.
- Normal wear and tear, cosmetic damage, broken cockpit glass, or gradual deterioration, including, without limitation, rust.
- Maintenance or operation not in accordance with Breville's maintenance and operating procedures.
- Product modified or altered in any way after the date of original purchase.
- PRODUCT USED FOR PERSONAL, FAMILY, OR HOUSEHOLD PURPOSES. - Damage to any other property, including without limitation real property, appliances, or personal property.
