CRITICAL COMMENTS:

Inspect premises thoroughly and locate all cockroach harbourages. Place BLATTATHOR Ultra Gel Cockroach Bait spots as closes as possible to cockroach harbourages. Place bait spots into cracks and crevices away from where they are likely to be removed by cleaning programs. When placing baits remember that the label refers to the full surface area that the cockroaches are likely to traverse e.g. in a kitchen allow for the full surface area of each bench, cupboard etc. Good hygiene is essential in any pest management situation. Encourage the removal of other food materials. Do not use chemical sprays near baits. In areas of poor sanitation use more bait placements.

RETREATMENT:

In areas of high activity the bait may be consumed and further placements needed. Schedule a second inspection about a month after the initial treatment. Retreatments only need to be applied in areas where cockroaches remain or are likely to enter the premises. BLATTATHOR Ultra Gel Cockroach Bait is very stable; it does not harden or lose its attractiveness to cockroaches. Only reapply baits when the original bait has been consumed.

STORAGE AND DISPOSAL:

Keep out of reach of children. Store in the closed, original container in a dry, cool, well-ventilated area out of direct sunlight. Do not dispose of undiluted chemical on site. Dispose of used containers in a local authority landfill. If no landfill is available, bury the containers below 500 mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burrt.

FIRST AID

If swallowed, do NOT induce vomiting but contact the National Poison Centre 0800 POISON (0800 764 766) or a doctor immediately. If in eyes wash out with running water for at least 15 minutes. If on hair or skin wash with plenty of soap and water.
