## DIRECTIONS FOR USE

1. Shake container well before applying.
2. Before applying NOVITHOR Resin ensure all surfaces have been thoroughly cleaned down with a wire brush, etc; and any mortar stains have been removed with acid wash. As all substrates are different, always apply to a small sample area first, to confirm suitable preparation, penetration and effect.
3. All holes in mortar joints where NOVITHOR Resin is to be applied must be filled with NOVITHOR Cementitious Parge.
4. Mortar joints on new buildings should be ironed in areas to be treated.
5. Do not apply NOVITHOR Resin in wet conditions.
6. When surfaces are thoroughly dry, apply NOVITHOR Resin with a low pressure spray ensuring mortar joints are flood coated from footing to 75 mm above finished ground level.
7. NOVITHOR Resin contains a detectable indicator, leaves a very mild semi-glazed finish and will emphasise the natural colour of masonry.

## PRECAUTIONS

As all substrates are different, always apply to a small sample area first, to confirm suitable preparation, penetration and effect.

## COVERAGE

Quantities below allow for a two coat application.

### Brickwork

1 litre per 2 sq. metres

### Concrete and cement render

1 litre per 2 sq. metres

### Concrete block

1 litre per 2 sq. metres

## CLEAN UP

Clean all tools and application equipment. Use lacquer thinners of DUCO type.

## STORAGE

Store in closed original containers, in a cool, well ventilated area away from children, animals, food and feedstuffs. Do not store for prolonged periods in direct sunlight. In case of spillage, confine and absorb spilled product with absorbent material such as sand, clay or cat litter. Dispose of waste according to the Australian Standard AS 2507. Do NOT allow spilled product to enter sewers, drains, creeks or any other waterways.

## SAFETY DIRECTIONS

Avoid contact with skin and eyes. Wear overalls, impervious gloves and safety glasses. Use in designated areas with adequate ventilation. Use approved flammable liquid storage containers in the work area. Prevent release of vapours and mists into workplace air. Keep containers closed when not in use. Take precautionary measures against static discharges. Keep material away from sparks, flames and other ignition sources. Do not empty into drains. Ensure a high level of personal hygiene is maintained when using this product, that is, always wash hands before eating, drinking, smoking or using the toilet facilities.

Avoid exposure. Do not handle until all safety precautions in the SDS have been read and understood. It is recommended that pregnant or breastfeeding women should not handle this product unless adequate exposure protection can be assured at all times.
