0.5 g active powder,
odour tablets, gauze strip

HSNO Hazard Classifications: 6.5A, 6.5B, 9.1A, 9.4A,

TOXICITY: Toxic - may cause respiratory sensitisation. May cause sensitisation from prolonged skin contact. Avoid inhalation of dust. Avoid skin contact.

ECOTOXICITY: Very toxic to aquatic organisms. Avoid contamination of any water supply with product or empty container. Very toxic to terrestrial invertebrates.

PRECAUTIONS:

Should not be used in areas accessible to children. Avoid spilling the contents of the trap. Wash hands and exposed skin before meals and after work.

DIRECTIONS:

Fill the proprietary In2Care Trap with 3.5 – 4.5 L of water.

Shake the sachet well before opening. Gently remove the gauze strip and pour the remaining contents of the sachet into the water in the Trap.

Slide the loop at the end of the gauze over one of the double pins and around the outside of the single pins. Ensure the gauze is fixed above the rim of the Floater. Avoid excessively touching the gauze.

Gently place the Floater onto the water in the centre of the Trap. Do not allow gauze to get wet.

Attach the centre tube of the lid into the centre pedestal of the base of the Trap and turn clockwise to lock it in position. Check the Trap every 4-6 weeks and repeat the above procedure.

PROTECTION OF LIVESTOCK, WILDLIFE AND OTHERS

DO NOT contaminate streams, rivers or waterways with the product or used containers.

STORAGE AND DISPOSAL:

KEEP OUT OF REACH OF CHILDREN. Store in the closed, original container in a dry, cool, well-ventilated area out of direct sunlight. Do not dispose of undiluted chemicals on site. Dispose of empty packaging and used gauze in normal garbage or to an approved waste management facility. Do not burn empty containers or product. Discard used water into a drain. Avoid release to the environment.

SAFETY DIRECTIONS:

Avoid contact with eyes and skin. Avoid inhalation of dust. Wash hands after use.

FIRST AID:
