<b>Occupational Release</b>	Minor spills do not normally need any special clean-up measures. In the event of a major spill, prevent spillage from entering drains or water courses. ### Eye Protection

<b>Incompatible materials</b>	ACIDS: reaction can occur, yielding heat and pressure which can burst an enclosed container.
