Judging and the Prizes

All Eligible Entries will be reviewed within 28 days of the end of the Promotional Period by a panel of judges comprising of employees of the Promoter and its related bodies corporate and employees of the Promoter's partner Her Black Book ("Panel"). The Panel will determine, in its absolute discretion, Eligible Entries that best satisfy the Judging Criteria.
