#### Toxicological Effects:

Hop Extract has a long history of safe use as a beer ingredient.

**(a) Acute toxicity:**

Typical hop extracts are not classified as hazardous.  
Estimated ATE values (oral, dermal) are >2000 mg/kg bw.

**(b) Skin corrosion/irritation:**

Skin Irritation Category 2.

**(c) Serious eye damage/irritation:**

Eye Irritation Category 2.

**(d) Respiratory or skin sensitisation:**

Skin Sensitisation Category 1.

**(e) Germ cell mutagenicity:**

OECD Guideline 471 (Bacterial Reverse Mutation Assay) not mutagenic. Bacterial Reverse Mutation Assay on 40%  $\beta$ -acids: not mutagenic.

**(f) Carcinogenicity:**

Long history of safe use as a component of beer. Bacterial reverse mutation assay: not mutagenic.

**(g) Reproductive toxicity:**

Weight of evidence indicates lack of reproductive toxicity. Long history of safe use as a component of beer. Hop extracts are generally recognised as safe (GRAS) in accordance with US FDA regulation 21 CFR 182.20.

**(h) STOT-single exposure:**

Weight of evidence indicates safety when used for its intended use – see (g) above.

**(a) STOT-repeated exposure:**

Weight of evidence indicates safety when used for its intended use – see (g) above.

**(b) Aspiration hazard:**

Not an aspiration hazard.
