


USER MANUAL





Roll up the rash guard into a ball facing the logo up, put sleeves inside and place it into the center of microwave. **Heat it for 3–4 mins at 700 W.** Take it out, roll up the rash guard into a ball the way the logo is hidden inside the rash guard and **heat it again for 3–4 mins from this side**. Follow this procedure to maintain gels equally heated. **Gels should feel WARM to the touch, NOT extremely hot.**





Place the rash guard **into the freezer for about 30 mins** to experience nice cold effect. Time might differ depending on your freezer. Longer you will keep it in the freezer colder the gels are going to be. **After approx. 2 hours** in the freezer the gels will reach **maximum freezing capacity** and even after more time in the freezer they won't get any colder. Rashguard can be stored in the freezer until it's ready to use. Gels will stay flexible even when they are frozen for a very long time.





Take your rashguard and hand-wash it in the sink or bathtub. Let it dry completely by hanging it on a hanger. Gels can be safely immersed in the water.

If you are using your customized embroidery patch attached to the velcro you should be able to wash it with it and it shouldn't limit the hand-wash process.

Do not wash in the washing machine. Hand-wash only.

Do not dry in the dryer.

Do not iron.

Do not bleach.

Do not dry clean.



PUTTING ON INSTRUCTIONS

Before putting on the ARMOR place it on the firm base and **adjust gels in the pocket by placing your palm over gel and pressing the gel pouch** to be evenly distributed in the pocket without major wrinkles.

Put your ARMOR on. Hook and close the zipper below the level of your hips to minimize the tension on the zipper. For more info watch emonstrational video on our website: www.gun-ex.com/product/armor/

If needed you can adjust gels on your body to perfectly copy your body curves.

Rash guard should be skin-tight.

TAKING OFF INSTRUCTIONS

Unzip the zipper, take the ARMOR of your shoulders and **do couple of hops**. ARMOR will naturally fall down on the ground by its own weight. No hassle.

If you are not sure which size to select and you are somewhere **between two sizes** (e.g. between Small and Medium) **choose smaller one**. You want to have ARMOR skin-tight and it will adapt your body due to its extreme elasticity.

USAGE INSTRUCTIONS

ARMOR can be used for most of the exercises and training routines. You do not have to take it off like standard weight vests. Armor is not compromising movements. It fits tightly on your body. That is why you can perform all dynamic exercises and training protocols like vertical jumps, huge leaps, sprints, changing movement directions, agility drills etc. You can also use it for slow and low impact exercises or bodyweight training.

ARMOR can be used indoors or outdoors, even in the water. Always use with supervision in the water. Due to its weight it can increase the chances of drowning. If used in the water do not forget to hand-wash it in fresh water right after exercising.

ARMOR should not be used in the case where your body is in contact with sharp edges, sharp objects or under extreme weight. It might result in gel pads perforation.

ARMOR can be used as recovery and rehab tool or thermotherapy and cold therapy.

ARMOR can be heated (see the Heating instruction paragraph) and used as thermotherapy or in harsh/cold weather conditions to maintain body temperature during the workout. Gel pads heating effect last for approx. 30–45 minutes.

ARMOR can be cooled down (see the cooling instruction paragraph) and used as cold therapy or in hot weather conditions to help thermo-regulate body temperature during the workout. Gel pads cooling effect lasts approx. 30–60 mins.
