GENERAL TERMS: This Credit Application ("Application") is between Hoffman Fine Chemicals Pty Ltd ("Hoffman Fine Chemicals", Australian Business Number 55 662 524 512, including its successors and affiliates) and the Applicant named above ("Applicant"). Applicant acknowledges it is furnishing the information requested herein, including Applicant's financial statement, for the purpose of procuring credit from time to time with Hoffman Fine Chemicals. Applicant represents and warrants that said information is true and correct and an accurate and complete statement of Applicant's financial condition. Applicant authorizes Hoffman Fine Chemicals to obtain credit and financial information concerning Applicant at any time and from any source. Applicant authorizes Hoffman Fine Chemicals to contact the credit references listed herein and hereby grants permission to those references to release information about Applicant's credit history.

ENTIRE AGREEMENT: This Application, along with the terms and conditions set forth on Hoffman Fine Chemicals' quotations, as well as any other mediums of communication between Hoffman Fine Chemicals and the Applicant (including, but not limited to emails, telephone calls, telephone messages, faxes and other mediums), constitute the entire agreement between the parties and supersede any terms and conditions set forth on any purchase order submitted to Hoffman Fine Chemicals by Applicant. Applicant hereby agrees to be bound by such terms and conditions.

TERMS OF PAYMENT: In consideration of Hoffman Fine Chemicals extending credit to Applicant, Applicant agrees to pay for all material and/or services within thirty (30) days of the invoice date. All accounts are due and payable at the remittance address shown on the Hoffman Fine Chemicals invoice. Unless accompanied by specific remittance instructions, Applicant agrees that Hoffman Fine Chemicals is authorized to apply all unspecified payments at its discretion. Balances that have not been paid within thirty (30) days of the invoice date will be subject to a finance charge of 1.69% per month (equivalent to an annual percentage rate of 20.24%) accruing on a daily basis to any unpaid balance until full payment of debt and any finance charge. A portion of the month shall be treated as a full month for the purpose of calculating service charge and interest. Waiver of any service charge and/or interest for any month shall not be deemed a waiver of future charges. Applicant further agrees that with regard to such charges, Applicant and Hoffman Fine Chemicals are parties to a written contract. Applicant agrees to pay a reasonable fee for any checks which are returned for non-sufficient funds or are dishonored for any reason.

DISPUTE RESOLUTION: Any dispute arising out of this Application shall be resolved by litigation or binding arbitration at Hoffman Fine Chemicals' option and at a venue selected by Hoffman Fine Chemicals. In the event Hoffman Fine Chemicals elects binding arbitration, a single arbitrator shall preside over the arbitration and, if the parties cannot mutually agree upon a single arbitrator, then one shall be selected by the arbitration service selected by Hoffman Fine Chemicals. In addition to paying all sums due hereunder, Applicant agrees to reimburse Hoffman Fine Chemicals for all costs of collection including, without limitation, reasonable attorneys' fees, collection agency fees, expenses and costs including those associated with the filing of foreclosure actions on liens filed due to Applicant's nonpayment.

CREDIT LIMIT: From time-to-time Applicant may receive a credit limit which may exceed the credit limit requested by Applicant. Should the credit limit be exceeded, Applicant shall be liable for the full amount due and owing, including all amounts in excess of the credit limit, and further acknowledges that Hoffman Fine Chemicals shall have no liability arising out of a credit limit being exceeded.

ASSIGNMENT: Applicant agrees that it will not factor, sell or assign the debt related to the credit granted by Hoffman Fine Chemicals under the terms of this Application. Applicant will notify Hoffman Fine Chemicals immediately in writing of any changes in Applicant's legal entity, legal name or legal status, place of business, principals and/or owner, as well as any employees who are terminated and no longer authorized to purchase on the account.

APPLICATION OF LAWS: The parties submit to the non-exclusive jurisdiction of the State in which this Application is received by Hoffman Fine Chemicals and the law applying in that State is the proper law governing this Application.
