

**TERMS & CONDITIONS OF ENTRY:  
ROBERT WELCH 'GIFT FOR YOU' COMPETITION**

1. Information on how to enter and prizes form part of these Conditions of Entry.
2. Entry is only open to Australian (AUS) residents who are aged 18 years and older. Employees and the immediate families of the Promoter and its agencies associated with this promotion are ineligible. If you are under 18 years old as at the start date of the competition, you are required to obtain your legal guardian's permission to enter.
3. The Promoter reserves the right to verify the validity of entries and to disqualify any entrant who tampers with the entry process or who submits an entry that is not in accordance with these Conditions of Entry.

5. Promotion will commence 09.00 4<sup>th</sup> November 2021. Entries close 15<sup>th</sup> December 2021 23.59. (The Promotion Period)
