

**TERMS & CONDITIONS OF ENTRY**  
**ROBERT WELCH HOME ENTERTAINERS TIPS 'WIN 1 OF 3 \$500 VOUCHERS'**

1. Information on how to enter and prizes form part of these Conditions of Entry.
2. Entry is only open to Australian (AUS) residents who are aged 18 years and older. Employees and the immediate families of the Promoter and its agencies associated with this promotion are ineligible.
