GRANT APPLICATION POLICY

Only in Wisconsin Giving, Inc., is a 501(c)(3) Charitable Foundation formed by Dan & Deb Carey and the New Glarus Brewing Company. Due to the overwhelming number of requests for sponsorships and donations that the Foundation and Brewery receives annually, we believe it is helpful to outline our donation policy.

While any organization that supports the needs of our community and the people Wisconsin is eligible for a grant, preference is given to those that work in the areas of:

- Childhood Education
- Hunger Relief
- Health Care
- Housing

If you wish to be considered for a grant, you must:

- Complete a written application. Additional information may be requested.
- Be a registered 501(c)(3) tax-exempt or other qualifying organization
- If the request is for a specific event, complete the application at least 45 days prior to the date of the event

Examples of other qualifying organizations could be social welfare organizations pursuant to IRC Section 501(c)(4), labor and agricultural organizations pursuant to IRC Section 501(c)(5), veterans' organizations pursuant to IRC Sections 501(c)(19) and 501(c)(23), and certain governmental organizations such as schools, police and fire departments pursuant to IRC Section 170(c)(1).

While all applications are carefully reviewed, the Foundation is unable to grant every request. Priority consideration is given to organizations working in New Glarus and Green County. Local organization requests are evaluated based on their service and support of the New Glarus community. Priority consideration is also given to organizations that clearly benefit the children of our community. Examples of past donations include New Glarus Fire Department, New Glarus EMS, and New Glarus School District.

The Foundation also regularly donates to established charities that responsibly work toward the cure and awareness of terminal disease and illness. If a person or family in the New Glarus area is raising money due to financial hardships resulting from a medical emergency, but is not a registered charitable organization, they may request support directly from the Brewery. Emergency fund raising for a local person's health care are typically given cash donations.

Multiple donation requests from the same organization during the same twelve-month period are discouraged and will be declined. Multiple events or multiple districts working for the same organization will have to allocate the Foundation's donation within their own organization.

Finally, the Foundation and Brewery do not sponsor non-charity activities, for example paying for logo placement at auto or sporting events.
