# 4. First-aid measures

### 6. Accidental release measures

**Personal precautions:** No action shall be taken involving any personal risk or if you do not have suitable training or protection. Shut off all heating and ignition sources. Avoid breathing vapor or mist. Put on appropriate personal protective equipment (see Section 8).

**Protective equipment and emergency procedures:** Avoid dispersal of spilled material, runoff and contact with soil, waterways, drains and sewers. ### 7. Handling and storage

**Precautions for safe handling:** Put on appropriate personal protective equipment (see Section 8). Remove contaminated clothing and protective equipment before entering eating areas. Avoid contact with eyes, skin and clothing. Do not ingest. Avoid breathing vapor or mist. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. Empty containers retain product residue and can be hazardous.
