Important Safety Instructions

IMPORTANT: Read the assembly instruction section and safety precautions of this booklet carefully before removing the contents of this carton.

- 1. In certain circumstances electrical appliances may be a safety hazard.
- 2. This appliance is not intended for use by persons (including children) with reduced physical, sensory or mental capabilities, or lack of experience or knowledge, unless they have been given supervision or instruction concerning the use of the appliance by a person responsible for their safety. Young children should be supervised to ensure that they do not play with the appliance.
- 3. Do not check the status of the filters whilst the cooker hood is operating.
- 4. Do not touch the light bulbs after use.
- 5. Do not disconnect the appliance with wet hands.
- 6. Do not disconnect the power supply by pulling on the cable.
- 7. Do not flambé underneath the range hood.
- 8. Avoid free flame, as it may cause damage to the filters and can be a fire hazard.
- 9. Unplug the appliance before carrying out maintenance, cleaning or replacing lamps.
- 10. If the power cord is damaged, it must be replaced by the manufacturer, an authorised service centre or similarly qualified persons to avoid a hazard.
- 11. For indoor use only.
- 12. It is recommended to operate the range hood prior to cooking.
- 13. It is recommended to leave the range hood in operation for 15 minutes after cooking is terminated in order to completely eliminate cooking vapours and odours.
- 14. Turn off the range hood when not in use.
- 15. Do not use the range hood if it is damaged, especially the supply cord and the case.
- 16. Do not immerse the range hood in liquid.
- 17. The exhaust air must not be discharged into a flue which is used for exhausting fumes from an appliance burning gas or other fuels (not applicable to appliances that only discharge the air back into the room).
- 18. Regulations concerning the discharge of air have to be fulfilled.
- 19. There shall be adequate ventilation of the room when the range hood is used at the same time as appliances burning gas of other fuels (not applicable to appliances that only discharge the air back into the room).
- 20. Clean the surface of the cooker hood regularly using a cloth moistened with denatured alcohol or a nonabrasive liquid detergent.
- 21. There is a fire risk if cleaning is not carried out in accordance with the instructions.
- 22. The 600mm units are intended for use above hobs that are 600mm wide and the 900mm units are intended for use above hobs that are 900mm wide.
- 23. The range hood must be mounted at a minimum distance of 65cm above the cooking surface.
- 24. **CAUTION**: Accessible parts may become hot when used with cooking appliances.
- 25. **Warning**: Failure to install the screws or fixing device in accordance with these instructions may result in electrical hazards.



Pre-Installation

Installation position

Minimum height from the cooktop surface to the underside face of the rangehood is **650mm**.

Note: If the instructions for the cooktop specify a greater distance, this has to be taken into account.

Any installation above 750mm will compromise performance.

Ducting Options

The method of ducting should be carefully considered before installing the rangehood. The guide below recommends the ducting components to use for all common ducting configurations - through the top of the home (for the roof and soffit) and through the rear of the home.

150mm round ducting should be used in conjunction with this model rangehood. Alternatively this rangehood can be operated in recirculation mode.


The highlighted area in the table below gives the recommended Uniduct item numbers for different mounting and outlet options.

Extra lengths and/or bends may be required, depending on the length required and whether there is any structural material in the run e.g. rafters.






Installation


Mounting to a stud is recommended. However, if fitted to other wall linings (plasterboard, concrete etc) suitable fixings will be required. Before drilling any holes check that the wall and ceiling are clear of any electrical cables, pipes etc. It is recommended that at least two people are used to install this appliance.




- Mark the correct height of the rangehood base on the wall and check that it is level using a spirit level. Measure up 22mm from the line. Place the fixing bracket with the line through the mounting holes (hooks facing upwards) and mark the position of the three holes in the fixing bracket against the wall. Check the holes will be in line and be level. Drill the three holes and (for brick walls) place the wall plugs in the holes. Fix the bracket in place with three ST4x40mm screws and tighten in place.
- 2. Insert the upper chimney piece into the lower chimney piece. Assemble the lower chimney bracket onto the lower chimney using two ST4x8mm screws and ensure the bracket holds both chimney pieces. Do not fully tighten the screws as some adjustment is required in step 9.




3. Screw the one way outlet to the top of the appliance using the four ST4x8mm screws, and fit the Ø150mm exhaust tube to the top of the outlet.



Installation



- 4. Pick up the appliance and place it onto the hooks. Remove the filters. Mark the two safety screws hole positions (in the back wall of the appliance) against the wall. Place the chimney assembly on the top of the main body. Mark the positions of the lower chimney bracket holes. Raise the upper chimney to the final fixing height (cut the cornice moulding away if required, to enable the chimney to sit flush against the wall and ceiling). Mark the upper edges of the chimney against the wall. Lower the upper chimney down and place the upper chimney bracket between the lines (mounting holes to the top) and mark the two mounting hole positions against the wall. Remove the bracket and chimney assembly, and remove the appliance from the wall.
- 5. Drill the holes for the two chimney brackets and the two safety holes. Place wall plugs in each hole. Fix the upper chimney bracket to the wall using two ST4x40mm screws. Place the appliance back on the fixing bracket and fasten in place using two ST4x30mm safety screws.
- Only if ducting Mark and cut out the hole in the ceiling / wall to fit the ducting (160mm diameter max).
 Warning: Chimney depth is 270mm. Ensure no part of the hole is greater than 265mm from the wall.
- 7. Connect and secure the ducting (use duct tape if required).
- 8. Place the chimney assembly back onto the appliance (take care the power cord is accessible & not trapped by the chimney). Fix the lower chimney to the wall using two ST4x40mm screws.
- 9. Extend the upper chimney to the ceiling and secure in place with two ST4x8mm screws (take care to tighten all screws when lined up).



10. Replace the filters. Remove any protective plastic (including from the filters). Connect to the power source.

Recirculation mode

- This unit can be installed to operate in recirculation mode where ducting is not a chosen/desired or practical option. There are recirculation grilles fitted on each side of the upper chimney which allow the cleansed air to return to the kitchen. Ensure that the side outlet grilles are not obstructed. Even a partial obstruction will restrict the efficiency of the rangehood.
- 2. Replace aluminium filters with charcoal filters.

Controls

Once the appliance is connected to the power source, the backlight of the control panel will turn on for 5 seconds, and then turn off, leaving the appliance in stand-by mode. Pressing a control button will light up an indicator light while the function is active, and then turn off when the function is deactivated.

Lights

The light can be operated independently from the fan. Press the fan button once and the LED lights will turn on. Press a second time and they will turn off.

Fan speed


The exhaust fan is operated by the three fan speed buttons. Pressing the button once will turn on the fan (low, medium and high speeds) and pressing a second time will turn the fan off.

Timer

When the exhaust fan is in use, pressing the Timer button will set up a 5 minute delay, after which the appliance will return to stand-by mode.

NOTE: if the lights are on, these will turn off as well, but the function will not work if only the lights are on.

Filter



To remove the filter, pull down the front panel and let it hang down. Press in the handle of the filter to release the fixing tabs and rotate the filter down. Pull the filter out. To replace the filter, fit in the opposite order as above.

General Maintenance

Switch off the rangehood before cleaning or maintenance.

To prevent surface damage never use abrasive or oil based liquid cleaners. To clean the surfaces of the appliance, use mild detergent and warm water. In areas of high humidity and coastal environments cleaning should be carried out frequently.

Warning: A buildup of oil may occur if the compact canopy is not cleaned regularly.

Filter Maintenance

To maintain efficiency, the filters should be removed regularly (approximately monthly), and washed using hot soapy water or the dishwasher.



A Some discolouration of the filter frame may occur if washed in the dishwasher.

Rangehoods fitted with charcoal filters are designed to remove grease and odours from cooking vapours prior to the cleansed air re-entering the kitchen (when the rangehood is in recirculation mode). Charcoal filters should be replaced every two to four months depending on use.



Fully saturated charcoal filters can become a barrier to air movement therefore limiting rangehood performance. In the event of fire, grease laden filters could be flammable and therefore regular replacement is recommended. In ducted installations, conventional aluminium filters are recommended.

Replacement of LED Lamps

The LED lamps cannot be replaced by the consumer. If any faults occur, please call your nearest Service Department.
