CONSIGNMENT CONTRACT

GENERAL TERMS

Under the terms of this Consignment Contract, the Consignor agrees to deliver goods to be sold by the Consignee, referred to in this document as "McCoy's Consign & Design." McCoy's Consign & Design agrees to place consignor's merchandise in store for sale. McCoy's Consign & Design will remit 50% of the selling price. Acceptance of merchandise for sale is at the discretion of McCoy's Consign & Design. The contract will remain in effect for all merchandise consigned. Consignor understands that while McCoy's Consign & Design agrees to use its best efforts to obtain a sale of the consigned merchandise, there is no guarantee a sale will occur. Consignor confirms that they have legal possession of each item being consigned.

Pricing:

We will work with you to arrive at a mutually beneficial sales price, considering such factors as McCoy's Consign & Design reserves the right to determine the actual selling price of all items. brand, age, condition, market demand, etc. **Items are subject to occasional advertised promotions and sale discounts no more than 20%**

CONSIGNMENT TERMS:

The Consignment term is 120 days. Merchandise not sold after 60 days McCoy's Consign & Design has the right to negotiate price within a 30% Margin of original price. **There is a 15% penalty for pulling and item early based on original sales price.**

Checks will be ready for you to pick-up at the store by the 5th of the month for the previous month's sales.

PAYMENTS:

Checks will be ready for you to pick-up at the store by the 5th of the month for the previous month's sales. Checks will be mailed to out of town consignors the 15 of each month. **After 6 months, checks not picked up. We be converted to store credit. Amounts under \$35.00 we be given as cash.**

RECORD KEEPING:

It is the responsibility of the consignor to maintain all records and terms of consigned merchandise. McCoy's Consign & Design will not be responsible for notifying consignors if their item has sold. Feel free to call the store any time for updates.

DROP OFFS:

All items dropped off are subject to the terms and conditions of the contract. Items in good condition (free of defects, odor, stains) Will go directly on the sales floor. Consignors will be responsible for all cost incurred on items that must be cleaned and or repaired. Items not in saleable condition will be donated if not picked up with in 48hours of being notified.

EXPIRED ITEMS:

Consignor agrees to allow McCoy's Consign & Design to market items for a period of 120 days. If your items have not sold at the end of this agreement period, you will have 10 days from the contract date to pick your item up or a possible chance at re-consigning at a different value.

INSURANCE:

McCoy's Consign & Design will take great care of the items you consign and have insurance coverage on the building and contents however, merchandise is yours until sold. Our Liability we be limited to making appropriate and timely payment to you for any of your items that we sell.
