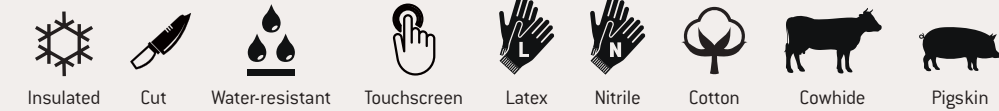

UNDERSTANDING SAFETY HELMETS TERMINOLOGY



TYPE I: Helmets that are intended to reduce the force of an impact resulting from a strike to the top of the hat.

CLASS E: Provides the most protection and withstands up to 20,000 volts.

6-POINT RATCHET SUSPENSION: The more suspension points in a hat help spread out the force of an impact.

INTERIOR FOAM PADDING: Works with the suspension by creating “safe space” to absorb shock from impact.

CUSHIONED BROW PAD: Segmented seam design for extra durability. Helps keep sweat soaked up and hat securely in place.

SHELL: ABS/PC material, low profile style with superior strength.

ROTATING INLINE DISC: Turn disc to adjust to head size— ranges from 6 ½ to 8.

BREAKAWAY 4-POINT CHINSTRAP: Standard EN 397 states the chin strap will breakaway at 15-25kg of pressure, therefore reducing the risk of strangulation.

ADJUSTABLE HEIGHT AND ANGLE ADJUSTMENTS ON THE SUSPENSION: Depending on user preference for balance, this helps give the wearer a lower center of gravity and the hat is less likely to fall off.

The 2020 edition of the standard has introduced markings for relaxed optics, anti-fog, and welding filter shades 15 and 16 and updated testing methods for transmittance allowance and auto-darkening welding filters dark-state.

CAN/CSA Z94.3-2020

The 2020 edition of the CSA standard has refined ignition resistance and flammability requirements, altered the coverage area requirements, revised the automatic darkening filter shades for welding, and clarified and adjusted several test methods, product markings, and labeling requirements.

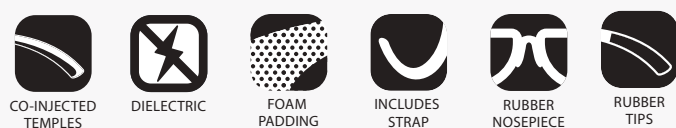
