GETTING STARTED


1. Before first use, charge your device for approximately 120 minutes. The USB charging cable can be plugged into any USB port of USB/AC power adapter (not included).


Our products are designed to be waterproof. Your device can be used in the shower and can be run under water in the sink to be cleaned.

DO NOT immerse your device in water.




2. Wash your device with soap and water, or toy cleaner suitable for use with silicone items.
