- After 31st December 2025, the frozen folios shall be referred by RTA/ Company to the administering authority under the Benami Transactions (Prohibitions) Act, 1988 and or Prevention of Money Laundering Act, 2002.
- Shareholders holding shares in physical mode are requested to ensure that their PAN is linked to Aadhaar by 31st March 2022, or any other date as may be specified by the Central Board of Direct Taxes to avoid freezing of folio.

In view of the above, members holding shares in physical form are requested to furnish valid PAN, KYC details and Nomination immediately to the Company/RTA in the required attached forms (as detailed below), to ensure that, their folios are not frozen on or after 01st April 2023.

Further. in terms of SEBI vide circular SEBI/HO/MIRSD/MIRSD_RTAMB/P/CIR/2022/8 dated 25.01.2022. issuance securities in dematerialized form has been made mandatory while processing service requests such as issue of duplicate securities certificate, claim from Unclaimed Suspense Account, Renewal/Exchange of securities certificate, endorsement, sub-division/splitting of securities certificate, consolidation of securities certificates/folios, transmission and transposition.
