


3 foot & 6 foot Drag Lite™ Models 10004485 & 10004486

Your shipping carton should have:

- (1) Rubber Drag mat
- (1) Blade bar assembly
- (1) Length of chain
- (1) Parts bag



- Parts bag for 3' model should have: (8) "U" Bolts & retaining plates (12) ¼" Nylock nuts (12) Washers
- Parts bag for 6' model should have: (12) "U" Bolts & retaining plates (20) ¼" Nylock nuts (20) Washers



ASSEMBLY:

- Place the rubber mat on the ground. One long edge should be facing you. (Pic 1)
- Place the red blade bar assembly (L shaped piece) on the mat. (Pic 2)
 The holes for the "U" bolts should be against the mat. The blade bar should be
 centered (left to right) on the mat. This will show you where the "U" bolts should
 be placed. (pic 2)
- Set the blade bar aside and push each "U" bolt up through the mat from the underside. **NOTE:** The "U" bolts straddle the wire that connects the rubber ribs.
- Place the blade bar back on the mat guiding the ends of the "U" bolts through the holes in the blade bar. Secure each with one retaining plate and two Nylock nuts. (pic 2)
- Pass the ends of the two remaining "U" bolts through the holes on each side of the blade bar and attach one end of the chain to each. Secure with retaining plate and two Nylock nuts. (Pic 3)

OPERATION:

Keep the blade bar on top of the mat to smooth a loose surface. Simply flip the mat over to use the teeth to loosen hard packed surfaces or to level high spots or fill in low areas.

NEWSTRIPE, INC., WARRANTS TO THE ORIGINAL PURCHASER, FOR 18 (EIGHTEEN) MONTHS AFTER DATE OF PURCHASE, THAT THE EQUIPMENT* HEREBY SOLD SHALL BE FREE OF DEFECTS IN MATERIALS AND WORKMANSHIP. THIS WARRANTY DOES NOT EXTEND TO ANY DAMAGE OR MALFUNCTION RESULTING FROM MISUSE, NEGLECT, ACCIDENT, IMPROPER OPERATION, OR NORMAL WEAR AND TEAR.

Damage incurred in shipment from Newstripe, Inc. to the customer is the total responsibility of the carrier. The CUSTOMER MUST NOTE DAMAGES on the Bill of Lading of Trucking Company or Railroad; and Newstripe, Inc. will furnish to the customer the cost or parts and labor. The customer can then bill the common carrier for the damages by placing his signature on the documents.

The Newstripe, Inc. obligation under this warranty and any implied warranties is limited to replacement or repair of defective parts of its manufacture without charge for 18 (Eighteen) months from date of purchase. For service under this warranty, buyer shall ship the defective part or parts of the equipment, transportation prepaid, to Newstripe, Inc. together with a written description of any claimed defect and proof of purchase date of the materials being returned. **Prior to retuning any part or machine, the CUSTOMER must obtain a Return Materials Authorization number. *Gasoline engines, compressors, pumps (including airless) and Transaxles are furnished with their respective manufacturer's warranties only. Such components are not covered by any warranty of Newstripe, Inc. Where Newstripe elects to extend manufacturers' warranties, the warranty shall be pro-rated as to cover 100% of the cost to replace or repair materials and parts for the first 12 months of ownership and 60% for the remaining 6 month period.

The responsibilities described above are the only responsibilities of Newstripe, Inc. under this written warranty or any implied warranty, and may be exercised only within 18 (Eighteen) months from the date of purchase. In no event shall Newstripe, Inc. be liable for incidental or consequential damages and no person had any authority to bind it to any representation or warranty, not be responsible for work done, materials furnished or repairs made by others without its' specific written authorization.

THIS WARRANTY SHALL BE IN LIEU OF ANY AND ALL OTHER WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING ANY WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, AND THERE IS NO OTHER REPRESENTATION OR WARRANTY OF ANY KIND WITH RESPECT TO THE GOODS SOLD HEREBY EXCEPT AS SET FORTH HEREIN. IT IS EXPRESSLY AGREED THAT THIS WARRANTY SHALL BE LIMITED TO THE ADJUSTMENT, REPAIR OR REPLACEMENT OF PARTS AND THE LABOR AND SERVICES REQUIRED THEREBY. IN NO EVENT, INCLUDING ANY CLAIM FOR NEGLIGENCE, SHALL NEWSTRIPE, INC. BE LIABLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES.
