(a) the product was purchased by the wholesaler directly from ALLSTAR LIGHTING SUPPLIES INC and from no other source; (b) if the product has been installed, the entire installation was performed by a state licensed electrician or under the supervision of a licensed electrician according to the product installation instructions & Operated according to specification, within specified input voltage, operating ambient temperature , and working with compatible ballasts /dimmers as suggested by ALLSTAR LIGHTING SUPPLIES INC; (c) the product was in its original, unopened and new condition at the time of installation; (d) product that has not been misused, carelessly handled

Buyer is responsible for all costs to de-install defective products and re-install replacement or repaired products and ALLSTAR LIGHTING SUPPLIES INC shall not be liable for labor for any consequential or incidental loss or damage, including any labor & expense costs or other costs related to the replacement or repair of the above-mentioned products. The warranty is not applicable to any products subjected to abnormal stresses and operating conditions. Loss or damage to the product due to abuse, mishandling, alteration, accident, electrical current fluctuation, failure to follow operating, maintenance or environmental instructions. Use of occupancy sensors, dimmers or programmable systems with some lamps or luminaires may void the warranty.
