The warranty is not applicable to any products subjected to abnormal stresses and operating conditions. Loss or damage to the product due to abuse, mishandling, alteration, accident, electrical current fluctuation, failure to follow operating, maintenance or environmental instructions. Use of occupancy sensors, dimmers or programmable systems with some lamps or luminaires may void the warranty.
