The rotation is locked into place by tightening the 4 adjustment set screws on the interfacing connection component, such as PDI's PR-SL. Rotation is positively controlled in 3 degree increments with the use of interfacing radial serrations. The slide is locked at the same time the four adjustment set screws of the interfacing component are tightened. If attaching to a PDI lock, torque the M6 bolts to 12 Nm (9ft lb). **US Pat No. 6,033,440 and 6,231,618.**
