These are the highlights of the changes available in this week's Phoenix DPMS release.

Optimizations and Fixes

The following fixes and optimizations have been added to Phoenix this week.

1. Addressed an issue and assigned sensible default values for all procedures (CDT codes) that involve coronal surfaces, so that the procedure settings are pre-set appropriately (e.g., required number of surfaces, all surfaces allowed).
2. Fixed the incorrect categorization of some procedures, which was interfering with the ability to post and claim these procedures in some cases.
3. Clinical event notes in the Hard Tissue Chart now appropriately reflect updates to procedure details, such as changes to associated anatomy.

4. Clinical event notes in the Hard Tissue Chart have been streamlined to handle multiple status updates and/or changes that occur within the same day, preventing the creation of unnecessary and redundant clinical note records.
5. Clinical event notes in the Hard Tissue Chart now also include records for treatment plan-based activities (e.g., treatment plan created / completed / discarded / updated).
6. Fixed a defect that involved the generation of claims for posted procedures in the absence of defined patient insurance.
7. Implemented a workflow improvement that allows users to create new insurance payers (companies) and plan “on the fly” when adding an insurance policy to a patient record.
8. Date of birth is now required when defining a new “person” record to ensure the all of the necessary information is defined when using this person as a responsible party / guarantor or insurance policyholder.
9. Date of birth is now validated to ensure that responsible parties / guarantors and insurance policyholders are legal adults (18 years or older).
10. Implemented some usability enhancement in the date of birth control that allow users more flexibility with the accepted input formats (e.g., with or without common delimiters, recognizing regional differences for month-day ordering).
11. Resolved a defect in the Patient Record in which changes to certain fields were not triggering a save confirmation when the user leaves the Patient Record UI without first saving the updates.
12. Fixed a UI defect that was occluding part of the Post New Charges dialog at the minimum supported resolution.
13. Fixed a defect so that confirmation status is reset when an appointment is rescheduled.
14. Addressed a defect so that treatment plan item status is reset accordingly when an appointment has been rescheduled, placed on the pending list, or deleted.
15. Resolved a UI defect that was occluding part of the Appointment Tile flyout at the minimum support resolution.
16. Fixed an interaction defect that was causing a shift in the Patient Record UI when entering a date of birth value under certain conditions.
17. Some UI simplification was completed, removing some currently unused navigational references in the Patient Record.
18. Resolved a logical defect in the Hard Tissue Chart for how to handle and count the split occlusal surface(s) present on some posterior teeth.
19. Performance enhancements and additional testing completed on the global patient search control.
20. Addressed a defect in the Hard Tissue Chart UI that resulted in the latest charted events against a tooth not being visually represented under certain conditions.
