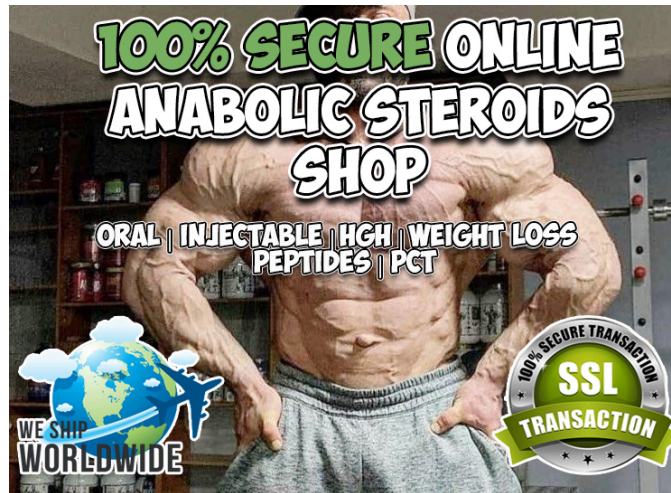

Prop 65 testing is designed to identify any product compliance issues, for the State of California. Prop

65 only applies to the state of California, however this includes all products distributed within the state. Therefore, if you are selling or distributing your products into California they must be Proposition 65 compliant. The Safe Drinking Water and Toxic Enforcement Act of 1986, often referred to as Cal Prop 65, is a California law intended to protect the State's residents and drinking water sources from toxic chemicals and to inform its citizens about exposure to them.

Our CA Prop 65 compliance services relate to the Safe Drinking Water and Toxic Enforcement Act, 1986 (also known as Proposition 65), which is a California law that was set out to promote clean drinking water and inform the public about the presence of toxic substances that cause cancer and/or birth defects in consumer products and their environment.
