

Introduction

In this whitepaper, we present Taboo, an exclusive adult NFT ecosystem powered by TABOO tokens. TABOO is a utility token built on the Binance Smart Chain that is incorporated within its own exclusive NFT (non-fungible token) marketplace. TABOO has a built-in static rewards program where holders passively earn more \$TABOO via an allocation of each transaction's 7% tax. Being a community driven coin, the primary goal of TABOO is to provide the community with the highest quality and exclusive NFT content, ensuring long term success of both investors and creators alike.

While there are many other adult industry entertainment marketplaces ranging from paid subscriptions to free content, Taboo aims to dominate the industry by offering premium content and exclusive memberships that utilize payment via TABOO tokens on the Binance Smart Chain. The Binance Smart Chain ecosystem allows users to utilize decentralized, lightning speed transactions with nominal fees, as opposed to centralized fiat payments. Content creators alike will also experience the simultaneous benefit of this blockchain technology, allowing instantaneous payouts and the elimination of middlemen (and their fees) in traditional fiat monetary systems. As cryptocurrency gains further widespread adoption, we are confident that Taboo will overtake traditional adult entertainment marketplaces and set a new precedent for quality content, ease of use, and engagement for both consumers and producers.

Token Information

he inaugural distribution of TABOO tokens was conducted via a public presale in order to provide the initial liquidity for trading. Half of the proceeds from the public sale were appropriated to the liquidity fund prior to launch and locked for an initial period of six months to ensure protection from rug-pulls. The initial utility of TABOO is for marketing, development and trading purposes. In time, the TABOO token will be used to access the Taboo NFT marketplace where users can buy, sell, and swap NFTs (see Q3 of the roadmap). In V2 of the NFT marketplace, users will be able to use their TABOO tokens to access the interactive NFT platform where they can directly engage with and tip content creators via private shows, group shows, custom NFTs, and more (see Q4 of the roadmap).

In time, the Taboo Token will be used to access the Taboo NFT marketplace



Presale (ILO)

• 20 percent of the supply (2B TABOO) were sold and distributed in a public initial liquidity offering prior to launch.

Marketing

 6 percent of the supply (600M TABOO) is allocated to marketing including social media campaigns, bounties, and advisors.

Liquidity


 10 percent of the supply (1B TABOO) are locked for an initial period of 6 months to provide trading liquidity.

Development

 6 percent of the supply (600M TABOO) is allocated to further development of TABOO including website updates, NFT marketplace development, exchange listings and future partnerships.








Taboo NFT Marketplace

"The pinnacle of the Taboo ecosystem will be its exclusive NFT marketplace. In Version 1, the user will be able to access and transact in the marketplace using TABOO tokens, which are subject to the aforementioned 7% tax tokenomics. The utilization of TABOO as the sole method of payment will ensure the health and integrity of TABOO's trade economy. The Taboo Marketplace will be accessible directly through the Taboo website, where users will be able to connect their personal BEP-20 supported wallets via a secure Web3 portal."

Key features of V1 include

- Exclusive NFT content from premium creators.
- Two entrances to the NFT Marketplace.
- Basic access for all TABOO holders with no minimum holding requirement.
- Tiered access and content for TABOO holders that meet the minimum tiered requirements.
- Bronze
- Silver
- Gold
- Weekly featured and promoted content creators.
- Content creator leaderboard with the opportunity to win weekly bonuses and features.
- Weekly NFT giveaways, contests and promotions.
- Continuous NFt giveaways for ALL TABOO holders.
- Top marketplace buyers and sellers leaderboard with the opportunity to win bonus content and prizes.



Key Features of V2

Payment options will be expanded and will include (but are not limited to)
 BUSD, USDT, BNB*.

in a continued effort to support the TABOO ecosystem, payment in options other than TABOO will be subject to a slight premium

- Fully integrated and interactive platform where content creators can offer personalized NFTs, streaming services, private shows, and more.
- Users will be able to pay for premium services and tips using TABOO.
- Creators will be able to set their own fees for users to access premium services such as private one-on-one cam shows.
- Creators will have the option to get paid out in different cryptocurrencies.
- Users will have the ability to support their favourite Creators by staking their profile, creating an ecosystem where both the User and Creator are rewarded.

Please note this could change if we are able to achieve features of V2 into V1 at deployment.




