### 4 FIRST-AID MEASURES

### **INHALATION**

Move the exposed person to fresh air at once. Rinse nose and mouth with water. Get medical attention if any discomfort continues.

#### INGESTION

NEVER MAKE AN UNCONSCIOUS PERSON VOMIT OR DRINK FLUIDS! Rinse mouth thoroughly. Get medical attention if any discomfort continues.

### SKIN CONTACT

Remove affected person from source of contamination. Remove contaminated clothing. Wash the skin immediately with soap and water. Get medical attention if any discomfort continues.

### **EYE CONTACT**

Immediately flush with plenty of water for up to 15 minutes. Remove any contact lenses and open eyes wide apart. Get medical attention if any discomfort continues.

# **EXTINGUISHING MEDIA**

Extinguish with alcohol-resistant foam, carbon dioxide, dry powder or water fog.

# SPECIAL FIRE FIGHTING PROCEDURES

Water spray should be used to cool containers. Dike and collect extinguishing water.

### SPECIFIC HAZARDS

Oxides of: Carbon.

### PROTECTIVE MEASURES IN FIRE

Self contained breathing apparatus and full protective clothing must be worn in case of fire.

### **6 ACCIDENTAL RELEASE MEASURES**

### PERSONAL PRECAUTIONS

Wear protective clothing as described in Section 8 of this safety data sheet. Avoid contact with skin and eyes. Provide adequate ventilation.

#### **ENVIRONMENTAL PRECAUTIONS**

Spillages or uncontrolled discharges into watercourses must be IMMEDIATELY alerted to the Environmental Agency or other appropriate regulatory body.

#### SPILL CLEAN UP METHODS

Stop leak if possible without risk. Absorb in vermiculite, dry sand or earth and place into containers. Flush with plenty of water to clean spillage area. Collect spillage in containers, seal securely and deliver for disposal according to local regulations.

### 7 HANDLING AND STORAGE

### **USAGE PRECAUTIONS**

Avoid spilling, skin and eye contact. Provide good ventilation.

### STORAGE PRECAUTIONS

Store in tightly closed original container in a dry, cool and well-ventilated place.

### PROTECTIVE EQUIPMENT





### **ENGINEERING MEASURES**

Provide adequate ventilation. Observe occupational exposure limits and minimize the risk of inhalation of vapours.

### RESPIRATORY EQUIPMENT

No specific recommendation made, but respiratory protection may still be required under exceptional circumstances when excessive air contamination exists.

### HAND PROTECTION

Use suitable protective gloves if risk of skin contact. The most suitable glove must be chosen in consultation with the gloves supplier, who can inform about the breakthrough time of the glove material.

### **EYE PROTECTION**

If risk of splashing, wear safety goggles or face shield.

#### OTHER PROTECTION

Wear appropriate clothing to prevent any possibility of skin contact.

## **HYGIENE MEASURES**

DO NOT SMOKE IN WORK AREA! Wash hands at the end of each work shift and before eating, smoking and using the toilet. Wash promptly if skin becomes wet or contaminated.
