### SECTION 3 – HAZARDS IDENTIFICATION

**Hazard Risk Classification:** Category 1

**Potential Health Effects:**

Eyes: May cause eye irritation.

Keep away from all possible sources of ignition. Store upright in a cool, dry, well ventilated location. Keep the container tightly closed.

Keep away from combustible materials, heat, steam pipe or sunlight. Keep away from oxidizing materials.

### **Other Precautions:**

Wash hands, face and other tools after work. Practice good personal hygiene after using this material, especially before eating, drinking, smoking or using the restroom.
