Congratulation for becoming the owner of Volt Caddy®, the latest generation of electric golf pushcart.

Please read the manual and guide carefully, to optimize your experience. Ensure the motor unit battery and remote control are fully charged.



WARNING:

It is very important to attach the Motor Unit to the cart frame before starting.

Please make sure to try and practice with the remote control in an open area until you are familiar with the maneuver.

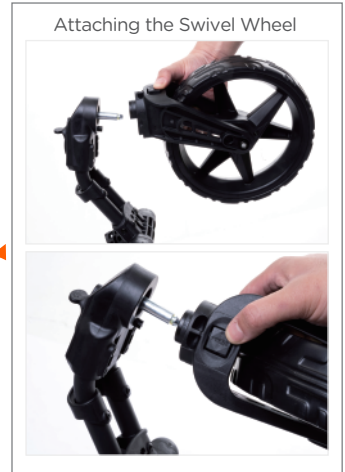

PARING THE REMOTE CONTROL



1 Turn ON remote controller : Press 2 times

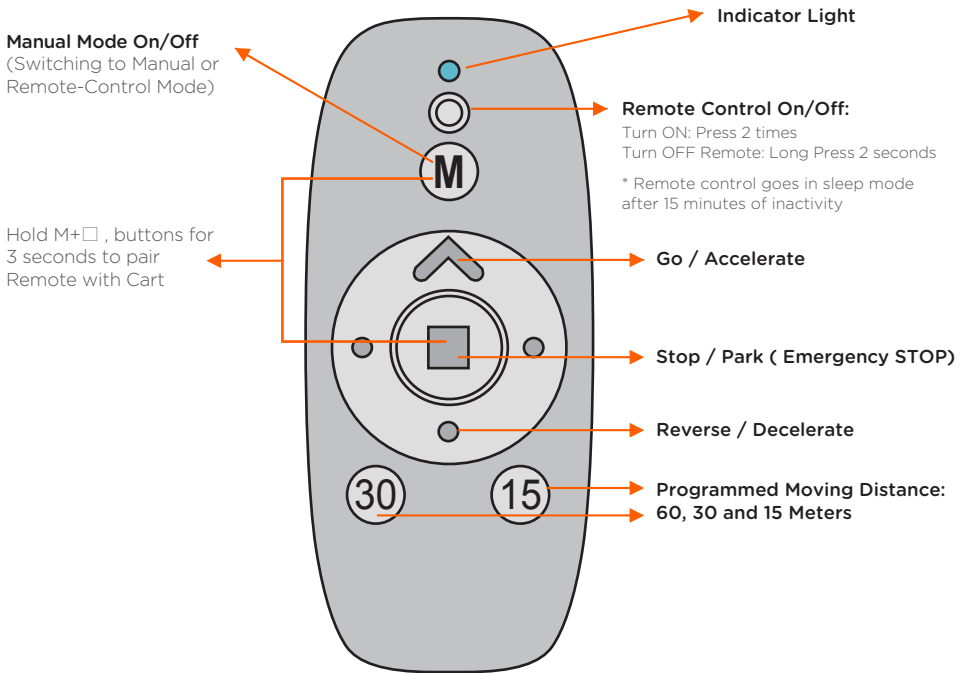
Ensure remote control batteries are inserted. (Battery required AAA).

2 Turn ON motor unit

3 Hold M+□ , buttons for 3 seconds to pair Remote with Cart.

When the light flashes, it is the window for syncing the Remote Control (around 3 seconds)

4 Confirm Indicator Light flashing



★★ TIPS ★★

It is very important to carry 2 spare AAA batteries on the course all the time

1 FOLDING AND UNFOLDING YOUR CART

UNFOLDING CART

Unfold the upper frame section fully

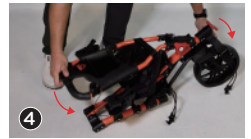
Lift the main frame from the central hinge until the lock clicks into position



FOLDING CART

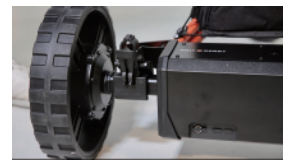
Press and hold the upper RED release button

Lift the handle and release the button



2 ATTACHING / DETACHING YOUR CART TO THE MOTOR UNIT

- 1 Ensure the cart frame is fully unfolded
- 2 Extend the wheels of the motor unit
- 3 Place the Axle Clamps onto the axle. Make sure the clamps are laying equally on the both sides of axles. Adjust both sides to ensure they are equal distance if necessary
- 4 Lock the axles by tighten the Clamps. (Reverse these steps to disassemble the unit.)



★★ TIPS ★★

- 1 It is very important to attach the wheel to the cart frame before starting the motor
- 2 The tightness of the clamp can be adjusted by turning the handle. The clamps should be tighten as much as possible to have stable motion. Loose clamps could cause unintended damages to the product that will not be covered under warranty

3 CONNECTING OR REMOVING THE BATTERY

★★ CAUTION! ★★

- 1 Make sure the unit is POWERED OFF before plugging and removing the battery
- 2 Make sure the battery is securely locked before using it on the golf course

To Remove the Battery:

- Pull the lock button
- Pull the battery handle to remove the battery



Plugging the Battery

- Position the battery on the bottom of Motor Unit from opposite side of the Lock Button .
- Pull the Lock Button
- Push the battery handle down to connect the battery



Dual USB Ports are available to charge your mobile devices

4 INSTALLING THE ANTI-TIP SUPPORT WHEELS

- 1 Push the button on the Support Wheel
- 2 Insert and link to the Axle Clamps
- 3 Ensure it is Locked to the upper part of the Axle Clamp



IMPORTANT INFORMATION

The Support Wheel attachments and angle could be adjusted using a screw-driver

5 STARTING YOUR VOLT CADDY

★★ TIPS ★★

It is very important to attach the wheel to the cart frame before starting. Start the motor without cart attached, could cause unintended damages to the product that will not be covered under warranty

- 1 Push the START Button
- 2 Light Flashing indicates that it is been started
- 3 The batter level is indicated by the number of light
- 4 When the light flashes, it is ready for syncing the Remote Control (around 3 seconds window)



Power On / Off Button

6 CHARGING BATTERY & MAINTENANCE

- Plug the charger into the Motor Unit.
- The LED indicator on the battery charger will turn red when charging begins.
- When charging is complete, the LED indicator on the charger will change from red to green.
- It should take about 4 hours to fully charge the battery
- Unplug the charger after charging is complete, to prolong battery life and prevent over-heating.

MAINTENANCE

- For safety, use only chargers provided by the manufacturer.
- Overcharging voltage or current may cause damage to this product.
- Store the unit and the charger in a cool, dry place and avoid direct sunlight
- Avoid soaking or drop the battery in water
- Dropping the battery may cause damage to internal components and BMS



7 PARING THE REMOTE CONTROL


★★ TIPS ★★

It is very important to carry 2 AAA batteries as spare all the time

1 Ensure remote control batteries are inserted. (Battery required AAA).



2 Pair your remote with Volt Caddy by pressing :

- Press Power button on the Motor Unit. When the light flashes, it is ready for syncing the Remote Control (around 3 seconds)
- Press M and  buttons for 3 seconds (this only requires at first time syncing).
- Wait until the motor unit light flashes



INDICATOR LIGHT INSTRUCTION

IMPORTANT INFORMATION

When going uphill or downhill on a steep slope, the indicator light may show rapid change, which is caused by a quick voltage change. It will return to normal power

- Light Flashing : The motor is started or it successfully synced with remote control
- 5 Light = Battery is full, 1 Light = Battery is low



WARRANTY POLICY AND INCLUSIONS



The Volt Caddy® is covered by a Limited* Comprehensive manufacturer's warranty from the date of purchase. The manufacturer's warrant covers manufacturing defects that occur through normal use on a golf course. Any breakage and defect caused by accidental damage or as a result of abuse and misuse or commercial use is not covered.

Duration of this warranty is:

- 24 months on cart parts*
- 12 months on lithium batteries
- 24 months on battery chargers
- 12 months on motor and control unit.

* Volt Caddy® or an authorized service center will repair or replace any parts found to be defective in materials or workmanship under normal use provided that:

- The Volt Caddy® has been properly used, maintained and regularly service per the manual instructions.
- The replacement or repair is performed by an authorized service center or the owner with approval.
- The caddy has been bought from a recognized distributor or reseller.

WARRANTY EXCLUSIONS



The following events causing unintended damages will void warranty:

- Start Volt Caddy before the clamps on the axles are tighten and they are fully locked
- Accidental damage, consumer misuse, abuse or neglect
- Any alteration performed by non-authorized people or companies.
- Any damage caused by continued operation of the motorized caddy after it is known to be defective.
- Damage to the axles by standing on it
- Damage caused by ingress of water into CPU and other major components
- Damage caused by caddy going into bunkers and other course hazards
- Failure to follow battery charging instructions, or using any charger purchased from an unauthorized supplier.

MAINTENANCE



- DO NOT STAND on the Axles or on the Motor unit.
- Avoid starting the motor unit if Axles Clams it not attached and locked
- Try to minimize exposure to rain as much as possible
- To prevent water damage, never use a pressure washer to clean the motor unit.

SAFETY FEATURES



Volt Caddy is fitted with safety cut off features:

- The remote control will turn to idle mode after 15 minutes no activity. To reactivate, press "START" 2 times
- While moving, if the caddy is out-of-range of the remote control, it will cut power to the motors.
- Please use "Manual Mode" and push the cart, if the area is too narrowed and dangerous
