Research and Inquire

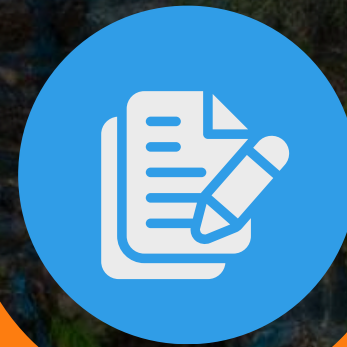
Negotiate Purchase Price

Draft Purchase Contract

We will create a purchase contract outlining the terms and conditions of the sale, including the agreed-upon price, any contingencies, and the closing date.

Sign Contract

Sign the purchase contract electronically via Adobe Signatures, ensuring that all parties involved are in agreement. Buyer will also pay the down payment.



Receive Notarized Deed

Once the contract is signed, we will provide a notarized deed transferring the title of the land to the Buyer. The buyer will meet in-person at a convenient location with our team member to pay with a cashier's check and receive the notarized deed.

Record the Deed

File the deed with the appropriate government office, such as the county's recorder office, to officially record the transfer of ownership and establish you as the new owner of the land.

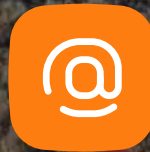
