Conciseness and Clarity: 4

Again you needed to emphasise the car accident at the end on the paragraph more. "It is important to note that..." — remember you are writing to a neurologist and this is the most probable cause.

Genre and Style: 6

Good. No issues. Just remember 'attended alone' not 'presented alone' – this is not a grammar problem but a collocation issue.

Organisation and Layout: 6

Clear. No issues – your letter is easy to follow and logically organised.

Language: 4
