## **OFFICIAL RULES**

Employees, officers and directors of DAVEXLABS, LLC, d/b/a L'ANZA ("**Sponsor**", "us" or "we"), its parent company, and each of their respective affiliates, subsidiaries, advertising and promotion agencies, distributors and other prize suppliers (collectively, the "**Contest Entites**"), and each of such employees', officers' and directors' immediate family members and/or those living in the same household (whether legally related or not) are not eligible to enter the Contest or win a prize. - Where do you hope to be in ten (10) years?

C. \*Video Submission: If you wish to submit a video (up to five (5) minutes in length) with your answers to the Personal Responses area, you may do so in lieu of a written portion. Please indicate you will be submitting a video in that area, by checking the box. \*\*Include video specs\*\*\* and you must submit a YouTube link or Dropbox link to your video submission. A video submission is not required to submit an Application. However, applicants must submit either written answers to the questions or a video response to the questions. For purposes of this Contest, a Submission is a video, essay and/or photograph file that follows the technical, creative, and legal requirements disclosed on the Contest Website and elsewhere in these Official Rules, including, without limitation, the Content Guidelines (defined below).

D. Letter of Recommendation: Submit a Letter of recommendation from an instructor or employer that vouches for your amazing potential.

E. Photos: Submit three (3) photos of artistic work on a friend, family member, or mannequin head. The formats accepted: JPEG, PSD, or TIFF.

For purposes of this Contest, a Submission is an Application which must include a video, essay and/or photograph file(s) (each, a "**Submission**") that follows the technical, creative, and legal requirements disclosed on the Contest Website and elsewhere in these Official Rules, including, without limitation, the Content Guidelines (defined below).

Limit of one (1) Application per person/email address for the Contest. An Application/Submission may, in Sponsor's sole and absolute discretion, be rejected if it fails to follow the technical, creative, and legal requirements disclosed on the Contest Website and in these Official Rules. The database clock of Sponsor's Contest Website will be the official timekeeper for the Contest. 4. <u>Submission Content Guidelines</u>. Submissions that do not meet the following "Content Guidelines" are subject to disqualification and/or removal from the Contest Website (if applicable), each at Sponsor's sole and absolute discretion, so read and follow these Content Guidelines:

Applicant further represents and warrants that his or her Submission and all materials and matter therein: (a) (except for elements that are within the public domain) are wholly original with such applicant and are not a copy or imitation of any other material or applicant has all necessary rights to grant the Sponsor the rights granted hereunder and exercise such without obligation or liability to any third party; (b) will not infringe or violate any right whatsoever, including, without limitation, any personal rights (*e.g.*, defamation, privacy, false light, moral right, etc.) or any property rights (*e.g.*, copyright, trademark, right to ideas, etc.) of any person or entity and the use thereof will result in no third party liability or obligations; and (c) is not the subject of any threatened or pending litigation, claim or dispute that might give rise to litigation, which adversely affects or in any way prejudices, impairs or diminishes the rights granted hereunder or the value thereof. Applicant further represents and warrants that he or she has the right to agree to and fully perform consistent with these Official Rules and that he or she has complied and has obtained all permissions, licenses and consents that are necessary for the submission of the Submission and the use of the Submission and to verify compliance with the foregoing requirements. Applicant agrees to provide to Sponsor at Sponsor's request copies of all such permissions, licenses and consents. Further, applicant represents and warrants that Sponsor's use of any Submission, including any images, text and materials depicted therein, shall not violate an agreement to which such applicant has signed. Applicant agrees to indemnify and hold the Released Parties (defined below) harmless from and against any third party claims, to the extent arising out of or relating to any breach of any representation, warranty or covenant made by applicant in connection with his or her acceptance of these Official Rules or Contest activities.

7. <u>Determining the Winners</u>. After the conclusion of the Entry Period, each Application/Submission will be reviewed by a team of judges (the "**Judges**") assembled by Sponsor, who will review and judge all eligible Submissions based on the following judging criteria (collectively, the "**Judging Criteria**"):

25%: Creativity;
25%: Originality;
25%: Execution (e.g., grammar); and
25% Recommendation Letter.

Based on the total score the Judges assign to each Submission using the Judging Criteria, one (1) Grand Prize and two (2) Runner-up winning Submissions will be ultimately selected by the Judges and each individual who submitted a selected Submission will be potential "**Winners**", subject to confirmation that the potential Winners have met the eligibility requirements and complied with these Official Rules. If there is a tie after the Judges apply the Judging Criteria, Sponsor will bring in a tie breaking Judge to apply the same Judging Criteria to break the tie and determine the Winners.

8. <u>Winner Notification</u>. The potential Winners will be notified by mail, email and/or other method (as selected by Sponsor) on or about July 1, 2023, unless extended by Sponsor. The Sponsor is not responsible for false, incorrect, changed, incomplete or illegible contact information. Notification is deemed to have occurred immediately upon sending of an email or other electronic message, one (1) day after sending via a delivery service or two (2) days after mailing. The potential Winner(s) will be required to execute and return an affidavit of eligibility, a liability release, a publicity release and services and performances agreements (collectively, "**Prize Acceptance Documents**") within seven (7) days of date of issuance. If such documents are not returned within the specified time period, a prize or prize notification is returned as undeliverable, Sponsor is unable to contact a potential Winner or a potential Winner is not in compliance with these Official Rules, the prize will be forfeited and, at Sponsor's discretion, an alternate winner selected. A scholarship awarded in this Contest must be used in connection with tuition, fees, books, supplies and equipment required for Winner's accredited school/cosmetology program in 2023. The scholarship may not cover living expenses such as dorm fees, apartment rent, food, transportation or other related expenses. The scholarship will be awarded in the form of a check payable to the scholarship winner upon furnishing proof of program registration and payment of eligible expenses in excess of amount of prize. If proof of a lower amount is shown by Winner (*i.e.*, an amount paid is lower than \$5,000), the lower amount will be awarded as the prize. Proof of registration and eligible expenses must be submitted within six (6) months of winning the Contest as a condition of receiving the prize award. Prize scholarship will only be awarded to the winning applicant upon furnishing proof of registration and payment of eligible expenses.

Prizes are non-transferable, with no cash redemptions, equivalents or substitutions except at Sponsor's sole and absolute discretion. All prize details not specified in these Official Rules will be determined in Sponsor's sole and absolute discretion. **15.** <u>Dispute Resolution</u>. The parties each agree to finally settle all disputes only through arbitration; provided, however, the Sponsor shall be entitled to seek injunctive or equitable relief in the state and federal courts in Los Angeles County, California and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction.
